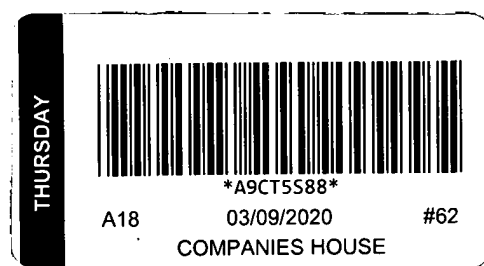

DIRECTOR'S STATEMENT


These accounts have been prepared in accordance with the provisions applicable to companies subject to the small companies regime.
