In accordance with Chapter 2 of Part 13 of the Companies Act 2006 (as amended from time to time), the directors of the Company have proposed that resolutions (1) and (2) below be passed as special resolutions (the Special Resolutions) and resolution (3) below be passed as an ordinary resolution:

SPECIAL RESOLUTIONS

THAT:

- (1) The articles of association set out in the document sent or submitted to every eligible member with this resolution be adopted as the articles of association of the Company in substitution for, and to the exclusion of, the existing articles of association of the Company.
- (2) The directors be given power to allot New Securities (as defined in the Company's articles of association (the Articles)), for cash pursuant to the authority conferred by Resolution (3) below as if the provisions of articles 12.3 to 12.10 (inclusive) of the Articles did not apply to any such allotment.

ORDINARY RESOLUTION

THAT:

- (3) Subject to and conditional upon the passing of the Special Resolutions, the directors be authorised, in accordance with article 12.10 of the Company's Articles and section 551 of the Companies Act 2006, to allot 19,060,606.00 series B preferred shares of £0.005 each in the capital of the Company, up to a maximum nominal amount of £95,303.03, having attached to them the respective rights as set out in the Articles to be adopted pursuant to resolution (1).

Eligible members must signify their agreement to the proposed resolution as follows: (i) by hand, by delivering a signed copy to any director or secretary of the company; (ii) by post, by sending a signed copy to any director or secretary of the company at 10 Norwich Street, London, United Kingdom, EC4A 1BD; or (iii) by e-mail, by sending a scanned signed copy of the resolution to ken@snoop.app. Eligible members must signify their agreement to the proposed resolutions within the period of 28 days from and including the circulation date (as defined below). However, eligible members who do not agree with the proposed resolutions do not need to reply. Once eligible members have signified their agreement to the proposed resolutions, their agreement may not be revoked. The proposed resolution will lapse if it is not passed by the end of that 28-day period.
