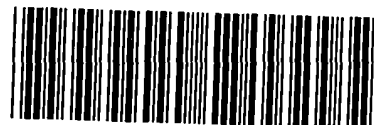

1. The purpose of this written resolution is to redesignate the share capital and to adopt new Articles of Association. If the resolution is an Ordinary Resolution a simple majority is needed in order for the resolution to be passed.
2. The circulation date of this written resolution is 15/04/2020.
