Furthermore, notwithstanding anything contained in these articles, the Company and the directors shall not be entitled to exercise any lien which the Company has in respect of those shares.

For the purposes of this article 26A "Secured Party" means any bank or financial institution (including, without limitation, Union Bancaire Privee, UBP SA) to which a security interest has been granted over the shares in the Company, or any nominee, receiver or other entity acting on its behalf."
