Our news service has covered reporting on large and small scale community events such as Remembrance Day, First Minister's Questions, Court reports, police and crime reports, the work of local and national charities. We have published many hundreds of press releases on behalf of the emergency services, the NHS in Wales, Welsh Government and numerous rural, town and county councils.

We have covered many events where the public may not have had access and therefore we gave them a front seat at the events by way of live streaming or a subsequent podcast. We have shared appeals for information relating to crime and missing persons.

We have travelled with our mobile recording studio and gathered public opinion on local, national and international events such as local elections, Senedd elections, UK elections and USA elections. We have supported student journalists by offering them placements and valuable work experience.

Our work has beneffitted the community by providing a free independent news service 24 hours a day seven days a week. We also offer a service for the blind and partially sighted by way of a talking newspaper. We champion local causes and promote local charitable fund raisers and events.
