





The 5 TOWNS VETERANS SUPPORT HUB CIC have been offering drop-in centre support (Covid-19 rules allowing) as well as telephone and email support to veterans and their families during the pandemic and beyond. We have engaged with over 600 veterans and their families during this period to help them with mental health support and benefit queries, as well as helping them avoid loneliness.

Our staff and volunteers have become Covid Community Champions and helped to dispel some of the rumours and falsehoods around the pandemic. We have encouraged veterans and their families to engage in the vaccination program with a reach of over 70 people per month during this period.

We have been targeting social isolation and mental health by encouraging veterans to re-engage with society after the lockdown eased, but to do so in a covid safe way.

Our stake holders are, Wakefield District Council, NOVA, SSAFA, The Yorkshire Volunteers Regimental Association (YVRA) and ASDIC (Association of Service Drop-In Centres)

All our stakeholders have been consulted about the progress of the projects and work. They get regular updates either at meetings or minutes of meetings provided by email.

Feedback has been provided by ASDIC that we have been given a clean bill of health and that they are happy with progress.

Wakefield District Council are happy with progress and have approved further works on the building. The building is now fully open.

SSAFAs feedback is that they are looking to utilise our site for partnership opportunities to provide support to their clients.

The YVRA have been providing volunteers and feedback has been that they are looking to push on with their own similar projects and expand a network of support hubs for veterans.


