

1 Introduction and Statutory Information

- I, Richard Jeffrey Rones of ThorntonRones Ltd, 311 High Road, Loughton, Essex, IG10 1AH, was appointed as Liquidator of Orrin Consultancy Ltd (the Company) on 14 September 2022. I am authorised to act as an Insolvency Practitioner in the UK by the institute of Chartered Accountants in England and Wales and am bound by the Insolvency Code of Ethics. In the event of case related queries, the Liquidator can be contacted by phone on 0208 418 9333 or via email info@thorntonrones.co.uk.
- 1.2 This report provides an update on the progress in the liquidation for the period from 14 September 2022 to 13 September 2023 (the period)
- 1.3 Information about the way that we will use, and store personal data on insolvency appointments can be found in the attached Privacy Notice A
- 1.4 The administrative base address of the Company was 147 Station Road, North Chingford, London, E4 6AG
- 1.5 The registered office of the Company was changed to 311 High Road, Loughton, Essex, IG10 1AH and its registered number is 1261609.

2 Progress of the Liquidation

- 2.1 At Appendix B, I have provided an account of my Receipts and Payments for the Period with a comparison to the Declaration of Solvency ("DoS") values.
- As members will be aware it was necessary to instruct the Company's accountant to prepare final accounts and Corporation Tax computations for the period ending 13 September 2022. This was required in order to obtain clearance from HMRC. In respect of this work the accountants were paid £500.00 plus VAT which was agreed by the member.

Assets Realisations

Bank interest

2.3 ThorntonRones Ltd holds all client funds in an interest- bearing bank account. Within the period the sum of £229.15 had been realised.

Cash At Bank

The DoS stated the only asset of the company was funds in the Company's bank account totalling £143,075.00. Following my appointment, the sum of £143,061.34 was transferred into the liquidator's client account.

Prepayment

2.5 On the 14 June 2022 an amount of £237.60 as paid into the client account from Lesser & Co the accountant, a credit they were holding for the Company.

3 Creditors' Claims

Unsecured Creditors

- 3.2 I would advise that a notice to claim was advertised in the London Gazette newspaper which required creditors to submit claims by 03 November 2022.
- 3.3 No claims have been received or identified in the period of this report.

4 **Distributions to Members**

- 4.1 The following distributions have been made:
- 4.2 A first interim cash distribution of £112,061.34 was made on the 23 september 2023 which was a return of £11,206.13 per share.
- 4.3 Formal clearance from HM Revenue and Customs has been received, however we still are waiting for a refund of £884.83 relating to losses for the year ending 13 September 2023 and the loss being carried back to year ending 30 June 2022 which created a credit due to the Company.
- 4.4 This being vigorously pursued with HMRC so a final distribution can be made to members and the liquidation closed. I will continue to update members directly on this matter in the forth coming period.

5 Liquidator's Remuneration

- 5.1 The members approved that the basis of the Liquidator's remuneration be fixed at £4,500 plus VAT and expenses. This sum has been drawn in full from the realisations of the Company's assets.
- 5.2 Attached as Appendix C is additional information in relation to the Liquidator's fees and expenses including where relevant, information on the use of subcontractors and professional advisers.
- 5.3 A copy of 'A Shareholders' Guide to Liquidators' Fees' is available on request.

6 Members' Rights

- 6.1 Within 21 days of the receipt of this report, members with either at least 5% of the total voting rights of all the members having the right to vote at general meetings of the Company or with the permission of the court, may request in writing that the Liquidator provide further information about his remuneration or expenses which have been itemised in this progress report.
- 6.2 Any members with at least 10% of the total voting rights of all the members having the right to vote at general meetings of the Company may within 8 weeks of receipt of this progress report, make an application to court on the grounds that, in all the circumstances, the basis fixed for the Liquidator's remuneration is inappropriate and/or the remuneration charged or the expenses incurred by the Liquidator, as set out in this progress report, are excessive.

7 **Next Report**

7.1 I am required to provide a further report on the progress of the liquidation within two months of the end of the second anniversary of the liquidation, unless I have concluded matters prior to this, in which case I will write again with my proposed final account.

Privacy Notice

Use of personal information

We process personal information to enable us to carry out our work as insolvency practitioners which includes processing data that was held by companies/individuals before our appointment together with data collected during an insolvency procedure or a fixed charge receivership. EXPENSES RECOVERY

In accordance with Statement of Insolvency Practice 9 (SIP9) expenses are categorised as either Category 1 or Category 2.

Category 1 Expenses

Category 1 expenses will generally comprise external supplies of incidental services specifically identifiable to the case. Where these have initially been paid by ThorntonRones and then recharged to the case, approval from creditors is not required. The amount recharged is the exact amount incurred. Category 1 expenses can be drawn without prior approval, although an office holder should be prepared to disclose information about them in the same way as any other expenses.

Examples of Category 1 expenses include postage, advertising, specific bond insurance, company search fees, invoiced travel and properly reimbursed expenses incurred by personnel in connection with the case. Also included will be services specific to the case where these cannot practically be provided internally such as printing, external room hire and document storage.

Category 2 Expenses

Category 2 expenses include elements of shared or allocated costs incurred by ThorntonRones and recharged to the case; they are not attributed to the case by a third-party invoice and/or they may include a profit element. Category 2 expenses may be drawn if they have been approved in the same manner as an office holder's remuneration. When seeking approval, an office holder should explain, for each category of expenses, the basis on which the charge is being made. Examples of Category 2 expenses are photocopying, all business mileage, internal room hire and internal storage.

The firm's current policy is that it does not recharge Category 2 expenses with the exception of mileage at the H M Revenue & Customs approved rate of 45p per mile. All costs are subject to VAT.

All the above costs are subject to amendment by ThorntonRones Limited at any time and any amendments will be reported to the appropriate parties in the next report or other document issued for general circulation.
