- 3. Ian Lawrence Goodhew (Replacement Officeholder) be appointed in place of the First Outgoing Officeholder in respect of each of the cases listed in Parts 1 and 2 of the Schedule, and in place of the Second Outgoing Officeholder in respect of each of the cases listed in Part 4

- 4. Abigail Shearing (**Replacement Officeholder**) be appointed in place of the Second Outgoing Officeholder in respect of each of the cases listed in Part 2 and in place of the First Outgoing Officeholder in respect of the case listed in Part 3 of the Schedule.
- 5. The Outgoing Officeholders shall receive their release as officeholders 28 days after the giving of notice to creditors (and, in the case of members' voluntary liquidations, the members) in accordance with this order, save that such release may be subject to further order in the event of an application by any creditor under paragraph 10 of this order for the specific case subject to that application.
