**1. Company information**

TH Estate Manco Limited is a private company limited by shares incorporated in England and Wales. The registered office is 4 Stable Street, London, N1C 4AB.

**2. Accounting policies**

**2.1 Basis of preparation of financial statements**

The financial statements have been prepared under the historical cost convention and in accordance with Section 1A - small entities of Financial Reporting Standard 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland' and the Companies Act 2006.

The financial statements are prepared in sterling, which is the functional currency of the company. Monetary amounts in these financial statements are rounded to the nearest £.

The company is a dormant company, as conferred by section 480 of the Companies Act 2006. Therefore the company did not trade during the period.

**3. Activities and profit and loss account**

The company has not traded during the period. During the period, the company received no income, incurred no expenditure and therefore made neither profit nor loss.
