Year ended 31 March 2021

1 General information

The company is a private company limited by guarantee without share capital and is registered in England and Wales. The address of the registered office is 155 Vauxhall Street, Brixton, London, SE11 5RH.

2 Statement of compliance

Basis of measurement and preparation of accounts

Deferred income
