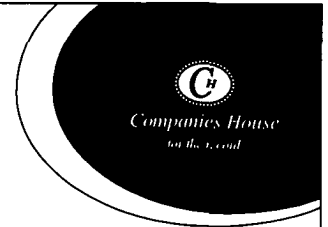

Variation	<p>(...CONTINUED)</p> <p>(a) The Conversion Notice shall state:</p> <p>(i) the number and class of Shares to be converted;</p> <p>(ii) the class of shares (Ordinary A shares, Ordinary F shares, Ordinary G shares or Ordinary H shares) into which the Shares are to be converted;</p> <p>(iii) the date for conversion or if no date is stated then the date for conversion shall be the date of the giving of a Conversion Notice.</p> <p>(b) Conversion of the Shares shall take place at the registered office for the time being of the Company on the conversion date specified above if the Conversion Notice is accepted by the holder(s) of Shares to whom it was sent and, for the avoidance of doubt, if the Conversion Notice is not accepted by the holder(s) of Shares to whom it was sent, then no conversion shall take place.</p> <p>(c) Each holder of Shares to be converted that accepts a Conversion Notice shall on or before the date for conversion deliver to the Company the certificates in respect of the shares to be converted for cancellation and the Company shall issue new share certificates at the rate of one fully paid Ordinary A share, Ordinary F share, Ordinary G share or Ordinary H share in the Company (as per the Conversion Notice) for each Share and if the holder of any Shares to be converted fails to comply with their obligation to deliver up the certificates of those Shares at the time of conversion, the Company may elect either:</p> <p>(i) to waive that obligation and proceed immediately with the conversion of those Shares, upon such (if any) additional terms as to indemnity as the Company may reasonably require; or</p> <p>(ii) to defer the conversion of those Shares until such time as certificates can be produced in respect of them.</p> <p>(d) The Ordinary A shares, Ordinary F shares, Ordinary G shares or Ordinary H shares in the Company shall have such rights as set out in the articles of association of the Company.</p>
