

Over the past year we have seen continued growth in our support and delivery of services to socially disadvantaged adults and young people. The diversity of what we offer and the additional programmes have been welcomed by the communities we serve.


Our youth sessions in Lambeth and Nine Elms continue to attract players who now see the organisation as part of their community. Young Players are now seeing the Street Soccer offer as 'more than football' often turning up early for additional support and relationships. The 'Bootroom' (a personal development programme) is now active after football sessions and very well attended and engaged. Our work in schools is growing too. This year has also created a number of Player Experiences which in partnership with others has created opportunities to attend PL football matches for example.

Our Adult programmes which provide support to adults affected by Homelessness, Mental Health and displacement are also expanding with a new site in Southwark and as well as the continued development and delivery of projects in Shoreditch and Lambeth. It is clear that our work has never been more needed.

As the programmes continue to grow, we are actively trying to secure a range of new income streams to allow sustainability. This will be a priority in the coming year with a series of fundraising events, partnerships and new funders being actively pursued.

We will also be actively recruiting new trustee/board members to ensure we have the experience, governance and diversity to allow the charity to flourish and that its mission is carried out to the highest standard and effectiveness.

Overall, we are happy with our progress thus far and are committed to furthering our impact into the next year.

Trustees Report for the year ended 30 June 2023

The trustees are pleased to present their report and financial statements of the charity for the year ended 30 June 2023. The charitable company was incorporated on 27 April 2021.

Objectives and Activities

The Charitable Objects of the organisation, as set out in the Articles of Association, are as follows:

To advance in life and relieve needs of young people in London through:

A/ the provision of recreational sporting or leisure time activities provided in the interest of social welfare, designed to improve their conditions of life

B/ Providing support and activities which develop their skills, capacities and capabilities to enable them to participate in society as mature and responsible individuals

To promote social inclusion for the public benefit by preventing people from becoming socially excluded, relieving the needs of those people who are socially excluded and assisting them to integrate into society by the provisions of:

A/ Football themed events and activities to create positive change in, and to motivate, inspire and develop people affected by social issues

B/ Raising public awareness of the issues affecting people with these types of social issues and delivering social change resulting in more positive outcomes and building hope and positivity to change their lives.

C/ Social and recreational facilities and events involving the local community

D/ Educational and personal development programs which help those who are socially excluded to gain life skills which help to connect and integrate them back into society

[For the purposes of this paragraph 'Socially Excluded' means being excluded from society, or parts of society, as a result of one or more of the following factors; Homelessness, Alcohol and Substance Abuse, Mental Health Issues and long term unemployment or refugees]

To provide or assist in the provision of facilities in the interest of social welfare or recreation or other leisure time occupation of individuals who have need of such facilities by reason of the social circumstances with the object of improving their conditions of life.

The Street Soccer London vision is:

At Street Soccer London, our vision is for young people living in tough areas to recognise and reach their potential, and to feel safe in and proud of their communities.

We play our part in this vision through football: by providing safe spaces, coaching and encouragement to play together at times when they might otherwise be at risk of getting drawn into local gang activity.

To do this, we embed ourselves in the local community. We base ourselves in community hubs and work with other community organisations focused on health and wellbeing.



Achievements and Performance

Street Soccer London's core values start with a "Players always come first" approach.

As we set out in 2020, our aim was to improve the life choices of our young players through connection, purpose, and opportunity. July 2022 – June 2023 has seen us grow our reach, expand our programmes, and embed further into the communities we serve.

YOUTH

- 16 hours of youth delivery per week across 4 locations and 2 boroughs

GIRLS

- Expansion of girl's sessions to 3 locations within Lambeth; including 3 new collaborations with Knights Youth Centre, Girls United and Fulham Foundation
- We are partnering with the London FA to bring female only coaching and refereeing courses to our 14+ players.
- A collaboration with a local organisation SR2 will lead to bespoke boot room activity for the girls' sessions.
- In association with Mabel and her management team we hosted Mabel at a Weds eve session and have since received donations of new boots and kit for the girls and a nutri bullet and some games
- The girls have taken part in several tournaments with community trusts and community events.
- Our Breaking Limits partnership has unlocked several opportunities inc a pre Womens World Cup panel event w Rexona speakers inc Laura, Eni Aluko and Sport England rep, we have also sent 2x staff to a weekend away with Man City team, taken a cohort of young people to WSL game at Stamford Bridge and a Chelsea pitch day experience.

ADULT

- Adult drop in is being delivered in 3 boroughs
- Funded prison for 12 months began delivery in May 2023 with Yasin as lead facilitator.

VOLUNTEERS

We are increasing our networks and working with more organisations to provide opportunities for volunteering both on and off the pitch

OFF PITCH

A new partnership with Academy of Real Assets will result in a series of boot rooms from Sep 2023 with 4 Real Estate organisations delivering employability and work ready workshops

Financial Review

The Financial Year performance to June 2023 has provided Street Soccer London with a great deal of satisfaction in an incredibly challenging Financial and Economic environment especially within the London Charity sector.

Street Soccer London's total incoming resources in the year were £458,664 (2022: £230,232) and total resources expended were £453,584 (2022: £227,501).

Within this Financial Year Street Soccer London has posted a surplus of £ 5,080 (2022: £2,731) and our total reserves have increased to £25,479.

This provides a balance of funds to meet all short-term working capital requirements. It is our intention to improve this balance over the next few years to assist in minimising the impact and risks associated with our cost base and future working capital requirements.

The main operational improvements this year have seen the organisation prepare and improve our Monthly Management Accounts and Budgeting.

Preparation of an Annual Budget has been further developed which has also been integrated on to our XERO Platform and allows Income and expenditure analysis against individual budget headings. A robust budget was in operation throughout the year and assisted regarding the control and monitoring of income/expenditures. This year's budget has been devolved to increase participation of our local staff and to maximise accountability and ownership.

A designated Bank Account was opened for the London operation in 2022 with Barclays PLC and has been functioning well from the beginning of the financial year.

It is our intention this year to improve and develop our short-term cash flow monitoring coupled with regular interaction with our Fundraising team regarding a longer-term forecast of future income streams. This will function as a tool to assimilate our future financial wellbeing and will also assist in our going concern evaluation.

We have now completed 2 full cycles of Annual Accounting with our new Auditors CT and we are confident that this partnership will improve and develop the scrutiny of our financial data/reports and will add to the checks and controls of any potential risks within our business.

RESERVES:

A Reserves Policy for the organisation has been prepared and the aim is to hold sufficient free reserves to safeguard the organisation against funding reductions and provide sufficient funds to meet liabilities.

The Board aims to maintain reserves equal to at least three months operating costs. The Board strategy is to build these reserves over the next few years.

The reserves that we set aside provide financial stability and the means to develop our principal activities. The ratio of reserves to Operating costs is calculated each month, and this is monitored by the London Operations Committee on a monthly basis and our Board on a quarterly basis.

The Trustees will review the level of unrestricted reserves that are required to ensure an adequate balance exists to fulfil our continuing obligations.

Future Plans

We will continue to work to our charitable objects, maintaining our successful youth programmes while building further on our Adult Programmes, Womens Programmes and Prison Programmes in the coming year.

Structure Governance and Management

Governing Document

Street Soccer London Limited is a company limited by guarantee and was established for charitable purposes on 15 April 2021. It is governed by its Memorandum and Articles of Association.



Recruitment and appointment of trustees


New trustees are appointed by existing members and selected based on skills and experience that new trustees can bring to the organisation.

This is chaired by the COO and attended by all SSS staff providing any form of support for London, the session concentrates on ensuring that actions are carried out and followed up, and that a coordinated approach is taken to all of this work.

Trustees responsibilities statement

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES AND MEMBERS OF

Street Soccer (London) Limited

I report to the charity trustees on my examination of the financial statements of the charitable charity for the year ended 30 June 2023 which are set out on pages 13 to 23.

Respective responsibilities of trustees and examiner

As the charity's trustees of the company (and also its directors for the purposes of company law) you are responsible for the preparation of the financial statements in accordance with the requirements of the Companies Act 2006 ('the 2006 Act').

NOTES to the FINANCIAL STATEMENTS

For the year ended 30 June 2023

1. General Information

The charity is a private company limited by guarantee, registered in England and it constitutes a public benefit entity as defined by FRS 102. The address of the registered office is 5 Beaufoy Walk, London, SE11 6AA. The charity was incorporated on 27 April 2020. It was registered with the Charity Commission on 15 April 2021.

2. Statement of Compliance

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland', the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (issued in October 2019), the Charities Act 2011, the Companies Act 2006 and UK Generally Accepted Accounting Practice.

Street Soccer (London) Limited meets the definition of a public benefit entity under FRS 102.

3. Accounting Policies Basis of preparation

The financial statements have been prepared on a going concern basis under the historical cost convention, as modified by the revaluation of certain financial assets and liabilities and investment properties measured at fair value through income or expenditure.

The financial statements are prepared in sterling, which is the functional currency of the entity.

Going concern

The financial statements have been prepared on a going concern basis. The Trustees have reviewed and considered relevant information, including the annual budget and future cash flows in making their assessment. In particular, the Trustees have tested their cash flow analysis to take into account the effect of possible scenarios brought on by the recent economic challenges, alongside the measures that they can take to mitigate the impact. Based on these assessments, given the measures that could be undertaken to mitigate the current adverse conditions, and the current resources available, the Trustees have concluded that, while there is an element of uncertainty due to unconfirmed future income streams, they can continue to adopt the going concern basis in preparing the annual report and financial statements.

Judgements and key sources of estimation uncertainty

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the amounts reported. These estimates and judgements are continually reviewed and are based on experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Funds structure

- Unrestricted funds comprise of accumulated net movement in general funds. They are available for use at the discretion of the Trustees in furtherance of the general charitable objectives.
- Restricted funds are funds subject to specific restricted conditions imposed by the donors.

Incoming resources

All incoming resources are included in the statement of financial activities when entitlement has passed to the charity; it is probable that the economic benefits associated with the transaction will flow to the charity and the amount can be reliably measured. The following specific policies are applied to particular categories of income:

- income from donations or grants is recognised when there is evidence of entitlement to the gift, receipt is probable, and its amount can be measured reliably.
- legacy income is recognised when receipt is probable, and entitlement is established.

3. Accounting Policies Basis of preparation (continued)

- income from donated goods is measured at the fair value of the goods unless this is impractical to measure reliably, in which case the value is derived from the cost to the donor or the estimated resale value. Donated facilities and services are recognised in the accounts when received if the value can be reliably measured. No amounts are included for the contribution of general volunteers.
- income from contracts for the supply of services is recognised with the delivery of the contracted service. This is classified as unrestricted funds unless there is a contractual requirement for it to be spent on a particular purpose and returned if unspent, in which case it may be regarded as restricted.

Resources expended

All expenditure is included on an accruals basis and is recognised when there is a legal or constructive obligation to pay for expenditure. All costs have been directly attributed to one of the functional categories of resources expended in the Statement of Financial Activities. Street Soccer London Limited is not registered for VAT. All items of expenditure are accordingly shown inclusive of VAT.

Pension costs

The charity operates a defined contribution scheme for the benefit of its employees. Contribution's payable are charged to the Statement of Financial Activities.






SSL Staff - Age




SSL Sessional - Age




SSL Board - Age




SSL Sessional - Gender



SSL Staff - Gender




SSL Board - Gender




Disability – Organisation Overview

SSL - Disability




Sexual Orientation – Organisation Overview


Religion or Belief – Organisation Overview

SSL - Religion or Belief




Ethnic Group


SSL Staff - Ethnic Group



SSL Sessional - Ethnic Group




SSL Board - Ethnic Group




SSL - Lived Experience
