2. THAT the articles of association annexed to this resolution shall be adopted by the Company to the exclusion of the existing articles of association.

3. THAT, in accordance with section 569 of the Companies Act 2006 (CA 2006), the directors of the Company be generally empowered to allot equity securities (as defined by section 560 of the CA 2006) as if section 561 of the CA 2006 did not apply to the allotment referred to in resolution 1 above.
