Definitions

"Aircraft"

means the Airframe together with the Engines (whether or not any of the Engines may from time to time be installed on the Airframe);

Airframe"

means the airframe McDonnell Douglas DC10 Aircraft having Manufacturer's Serial No. 48286 and Registration Letters 9G-ANA including all Parts now or hereafter installed in or on the airframe as at the date of this Aircraft Mortgage (or which, having been removed therefrom, remain the property of the Company pursuant to the terms of the Aircraft Mortgage) and all substitutions, renewals and replacements from time to time made in to or installed in or on the said airframe;

"Engines"

means (a) the three (3) General Electric CF6-50 C2 engines bearing manufacturer's serial numbers 517213, 517685 and 455712, whether or not from time to time installed on the Airframe or any other airframe but which, having been removed from the Airframe, remain the property of the Company or (b) any other engine which may from time to time be installed upon or attached to the Airframe which becomes the property of the Company and (c) insofar as the same belong to the Company any all appliances, instruments or accessories or other equipment or Parts of whatever nature from time to time relating to an engine referred to in (a) or (b) above whether or not installed on or attached to such engine and (d) in sofar as the same belongs to the Company, all substitutions, replacements or renewals from time to time made on or to any items referred to in (a), (b) and (c) above in accordance with the terms of the Aircraft Mortgage;
