

Governmental Agency means any government or governmental, semi-governmental or juridical entity or authority, including any self-regulatory organisation established under statute or any stock exchange

Insurances mean (1) the proceeds of all policies and contracts of insurances relating to the Aircraft, including both existing policies and contracts and those entered into in the future, which are required to be maintained in accordance with the terms of the Loan Agreement and (11) the right to make claims under all such policies and contracts of insurance (other than in respect of liability insurance)

Lenders mean the financial institutions named in Part A of Schedule 1 of the Loan Agreement

Loan Agreement means the loan agreement dated 18 November 2005 and made between the Borrower, the Assignee, the Facility Agent and the Lenders, under which the Lenders agreed to make available a loan facility of up to an aggregate amount of \$260,000,000 to the Assignor in connection with the financing of the Aircraft and the Other Aircraft.

Other Aircraft means the Boeing 747-400F freighter with manufacturer's serial number 34150 and the Boeing 777-300 aircraft with manufacturer's serial number 34243

Requisition Compensation means all moneys or other compensation from time to time payable in respect of the Compulsory Acquisition of the Aircraft

State of Registration means, in relation to an Aircraft, Hong Kong or any other state in which such Aircraft is registered pursuant to Clause 15 3 (Registration) and Schedule 11 (Registration).
