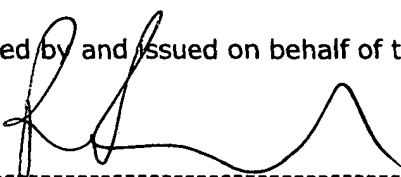

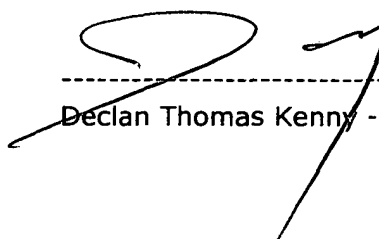

1. Compliance with Accounting Standards

2. Accounting Policies
These Financial Statements have been prepared under the historical cost convention with the exception of property, which is measured at fair value through profit or loss.
3. MBCC (1) Limited holds legal title to property situated at Monte Miraflores, Urbanización Hacienda Miraflores, Carretera de Cadiz km 205, Mijas-Costa, Malaga, Spain. The property was transferred to the Company in accordance with the terms of the Constitution and Trust Deed of the Miraflores Beach and Country Club and the Company holds no occupational rights or residual equity interest in the property. The property is therefore shown at nil value.
