OPERATING AGREEMENT

OF

LASER PERFORMANCE LLC

This Operating Agreement (this "Agreement") of **LASER PERFORMANCE LLC** (the "Company"), is entered into as of the 19th day of November, 2007 by Quarter Moon, Incorporated (the "Member") as the sole member of the Company.

Pursuant to and in accordance with the Delaware Limited Liability Company Act as amended from time to time (the "DLLCA"), the Member hereby states as follows:

- 1. Name. The name of the limited liability company shall be LASER PERFORMANCE LLC.
