CONTRACT FOR THE FORMATION OF  
LawExchange EEIG

European Economic Interest Grouping  
networking independent Law Firms throughout  
the Member States of the European Union and  
associating with correspondent Law Firms  
throughout Europe and in North America

THIS AGREEMENT is made the 9<sup>th</sup> day of May 1994

BETWEEN:-

- (1) Hewitson Becke + Shaw (a Partnership formed under and regulated by the laws of England but not subject to any form of registration and made between the parties listed in Schedule I hereto) whose permanent place of business is at Shakespeare House, 42 Newmarket Road, Cambridge, England.
- (2) Mateu Bourdin De Pins Albisson (Société en Nom Collectif formed under and regulated by the laws of France but not subject to any form of registration and made between the parties listed in Schedule II hereto) whose permanent place of business is at 650 Rue Henri Becquerel, Le Millenaire, 34000 Montpellier, La France
- (3) Heussen, Braun & Von Kessel (Gesellschaft bürgerlichen Rechts formed under and regulated by the laws of Germany but not subject to any form of registration and made between the parties listed in Schedule III hereto) whose permanent place of business is at Amiraplatz, 1/Briennerstrasse, 8000 München 2, Deutschland.

WHEREAS the parties are partnerships of qualified lawyers regulated by a recognised professional body and practicing in one of the Member States of the European Union

AND WHEREAS the parties wish to form together a European Economic Interest Grouping (as defined by Council Regulation (EEC) No 2137/85 of 25th July 1985 on the European Economic Interest Grouping) ("the EC Regulation") to facilitate and develop the economic interests of the members of such Grouping and to improve or increase the results of those activities, but not to make any profits for itself

NOW THIS AGREEMENT made for the purposes of forming such Grouping WITNESSETH as follows:-

1. Formation of EEIG

With effect from the date of this Agreement the parties hereto shall form an EEIG ("the Grouping") which shall be regulated and managed by the Articles of Government agreed between the parties, and initialled by their representatives to identify such agreement ("Articles").

2. Name of Grouping

The name of the Grouping shall be "LawExchange EEIG" or subject to the EC Regulation and the Articles, such other name as the members of the Grouping ("Members") may from time to time unanimously agree.

### 3. Official Address

The official address of the Grouping shall be Shakespeare House, 42 Newmarket Road Cambridge CB5 8EP England or subject to the Regulation and the Articles, such other place or places as the Members may from time to time agree. The parties shall procure that the Grouping is registered in England as an EEIG under the provisions of European Economic Interest Grouping Regulations SI 1989/638.

### 4. Objects of the Grouping

The objects of the Grouping are as follows:-

- (a) To facilitate and develop the economic activities of the Members and to improve or increase the results of those activities, but not to make any profits for itself.
- (b) To attract new clients for Members through the activities of the Grouping and to encourage the referral of legal services of all types by one Member to another Member experienced in the law of the jurisdiction for which such services are sought.
- (c) To disseminate among Members information relating to the scope, availability, specialisms, and charges of individual Members.
- (d) To encourage a consistent delivery of legal services to clients by Members.
- (e) To exchange information and expertise about the law of the jurisdiction of each Member and EU law.
- (f) To exchange information and expertise about the management of Members' legal practices.
- (g) To provide advice and consultancy services for projects of practice development for individual Members which are undertaken pursuant to the Articles.
- (h) To encourage the exchange between Members of trainee solicitors with appropriate language skills for short periods.
- (i) To encourage the exchange between Members of experienced lawyers with appropriate language skills and relevant expertise for longer periods.
- (j) To attract new Members approved by the Board from States not represented in the Grouping.

- (k) To afford to non-Members in countries within Europe but outside the European Union, and in North America, facilities to associate with the Grouping as legal correspondents on such terms as the Board may from time to time prescribe.

5. Duration of the Grouping

The Grouping shall come into existence on the date hereof and shall continue in existence for an indefinite period of time until there is only one remaining Member, or it is otherwise dissolved pursuant to the Articles or wound up in accordance with the EC Regulation.

6. Proper Law

This Agreement shall be governed by and construed in accordance with the laws of England.

7. Proper Language

This Agreement shall be executed in English, French, and German language versions, each of which shall constitute an official record of the agreement between the parties relating to the subject matter hereof.

8. Entire Understanding

This Agreement, together with the Articles, represents the entire understanding of the parties with regard to the formation of the Grouping and supersedes all prior proposals, agreements, and representations between them whether written or oral relating to such subject matter.

IN WITNESS whereof this Agreement has been executed by the duly authorised representatives of the parties the day and year first before written.




