

## **Notes**

- Notice relating to managers of an EEIG with an official address outside Great Britain must be given by form EEIG 4.
- A separate form must be completed in respect of each manager and if that manager is not a natural person it must designate one or more natural persons to represent it (regulation 5(1)). A Form EEIG 3 must also be completed in respect of each natural person and be sent to the relevant Registrar.
