2) The company KEVIOS LTD, , governed by United Kingdom law, having its registered office at International House, 221 Bow Road, London, England, E3 2SJ United Kingdom, legal form Private Limited by Shares registered at the registry of Companies House under number 8003778, represented in accordance with its articles of association by Miss Tripty Gurung as company

there is formed a European Economic Interest Grouping - EEIG, governed by Regulation (EEC) 2137/85 and by The European Economic Interest Grouping Regulations - Statutory Instruments (Great-Britain) 1989, No 638 - Her Majesty's Stationery Office, Section 510 A of the Taxes Act 1988 and Section 12A and 98B of the Taxes Management Act 1970

Article 1: Name

The grouping shall have the name GLOBAL REAL ESTATE INVESTMENT EEIG

Article 2: Object

The Group has as its object the development of economic interest of its members, with the aim to facilitate and develop the proper activity of each of them in the market for individual states and international membership and to improve and increase the results of the same. In particular, by enhancing the skills and abilities of members with emphasis on the fields of professional and entrepreneurial activities of the members themselves, favoring aggregation and cooperation on individual projects of medium and long term

In general, it can perform all the operations mentioned above and explicable by the object that will be likely to facilitate their deployment. For this purpose, the Group may in particular

- Buy and sell real estate in general, build, renovate, restore and perform routine maintenance of civil and industrial buildings both independently and under contract, administer and manage property, hire and lease real estate, real estate activities in general,
- Carry out various benefits and services to professional firms, professionals and individual members, as well as for businesses, organizations and companies, carry assistance in organizational, managerial and administrative support of the aforementioned parties (professionals, companies, organizations, businesses),
- Organize and manage human resources and / or business,
- Organize and / or manage training courses and professional training and management,
- Search, select and train qualified professionals in the legal and commercial aspects

Article 3: Official address

The official address of the EEIG shall be

Article 4: Duration

The duration of the grouping shall be indefinite

Article 5: Capital

The capital of the grouping shall be the sum of 5,000 £ divided into equal shares of 1 £

These shares shall be allocated to the members of the grouping as follow:

Kevios Ltd 4,900 Shares

Alessia Showrousk 100 Shares

Article 6: Contributions

The company Kevios Ltd shall contribute the sum of 4 900 £ to the grouping Mrs Alessia Showrousk shall contribute the sum of 100 £ to the grouping

Article 7: Financing

The grouping shall be financed by subscriptions or other contributions from members, under the conditions laid down by the members acting collectively by a majority of shares

Where appropriate, new members may be charged an admission fee, under the conditions laid down by the members acting collectively by a majority of shares

Article 8: Admission of new members

The admission of new members shall be subject to a decision by the members acting collectively by a majority of shares

The EEIG may enter into cooperation relationships with other persons resident or having their central administration outside a Member State of the EEA Such persons shall not be considered as members but may acquire the status of 'associate" The methods and content of cooperation relationships with such persons shall be laid down by the members acting collectively by a majority of shares

Article 9: Withdrawal of a member

Any member of the grouping may withdraw from the grouping with the agreement of the majority of shares of the members

Any member of the grouping may, in addition, withdraw on just and proper grounds

Such withdrawal shall take effect after notice has been served on the managers

Article 10: Expulsion of a member

Any member of the grouping may be expelled if he seriously fails in his obligations or he causes or threatens to cause serious disruption in the operation of the grouping

A decision to exclude a member shall be taken by a majority of shares

Article 11: Assignment of participation

Any participation in the grouping, or a proportion thereof, may be assigned either to another member or to a third party. Such assignment shall not take effect without the unanimous authorization of the other members

Article 12: Succession in the event of death

In the event of the death of a natural person who is a member of the grouping, authorization to admit his successor to the grouping shall be given by the remaining members by a majority of shares

Article 13: Rights and obligations of a member who withdraws

When a member shall cease to belong to the grouping for any reason other than the assignment of his rights in accordance with the conditions laid down in Article 11, the value of his rights and obligations shall be determined taking into account the assets and liabilities of the grouping as they stand when he ceases to belong to it

Article 14: Liability

The members shall have unlimited joint and several liability for its debts and liabilities of whatever nature in the same proportion as participation in the grouping's profits

Article 15: The members acting collectively

The members acting collectively shall include all the members of the grouping

They may take all decisions to achieve the grouping's objects

The members shall meet or be consulted at the initiative either of a member or a manager

This consultation shall take the form of either

- -a physical meeting
- -a telephone meeting
- -a teleconference

Decisions shall be taken by majority of shares. A unanimous decision by the members shall be required to

- a) alter the objects of the grouping
- b) alter the number of votes allotted to each member
- c) alter the conditions for the taking of decisions
- d) extend the duration of the grouping

e) transfer the official address of the grouping to another Member State of the EEA

Article 16: Managers

The grouping shall be managed by a manager(s) appointed by the members acting collectively by a majority of shares

Members or any other person or entity may be appointed as managers of the Group In case a legal person is appointed, it must designate an individual as a permanent representative

Article 17: Powers of managers

The manager(s) may perform any act required or useful for the achievement of the objects of the grouping, excepting those set aside by law or this contract for the members acting collectively

Article 19: Financial year

The financial year shall start on 1st January and shall end on 31st Dicember Exceptionally, the first financial year shall start on date of formation and shall end on 31st Dicember 2013

Article 19: Annual accounts

At the end of each financial year, annual accounts shall be drawn up by the manager(s) who shall submit them to the members for approval within 4 months of the end of the financial year

Article 20: Profits and losses

If the accounts show a profit, the members acting collectively may decide to allocate a certain proportion of these profits to a reserve fund, or to apportion them among the members pro rata to the number of their shares

In the event of a loss, the manager(s) may require the members of the grouping to contribute to the loss incurred in proportion of number of their shares

Article 21: Winding up

The members acting collectively may decide to wind up the grouping unanimously

Article 22: Liquidation

When the grouping is wound up, the grouping shall be liquidated by the manager(s)

Any assets or liabilities remaining after payment of the grouping's debts and liabilities shall be apportioned among the members pro rata to the number of their shares

Article 23: Languages

The present contract language being drafted in the English language shall be valid in the event of disputes as to its interpretation. It has been decided to use the English Language for any official dealings or communications between members
