

On 1 November 2005, Caisse de dépôt et placement du Québec transferred 32.15% of its interest in the partnership to Pantheon International Participations PLC, 47.25% of its interest in the partnership to Pantheon Global Secondary Fund II Limited and 20.60% of its interest in the partnership to Pantheon Global Secondary Fund II, L.P. On 1 November 2005, following such transfers, the aforementioned transferees were admitted as limited partners to the partnership and Caisse de dépôt et placement du Québec ceased to be a limited partner.
