- Secondary Overflow Fund L.P., transferred to the Transferee, the whole of its interests in the Partnership, comprising a capital contribution of EUR 388.40
- 3. HarbourVest Partners IX Buyout Fund L.P., transferred to the Transferee, the whole of its interests in the Partnership, comprising a capital contribution of EUR 74:65
- 4. HarbourVest Partners IX Venture Fund L.P., transferred to the "Transferee", the whole of its interests in the Partnership, comprising a capital contribution of EUR 80.71
- 5. HarbourVest Partners IX Credit Opportunities Fund L.P., transferred to the Transferee, the whole of its interests in the Partnership, comprising a capital contribution of EUR 19.13

Consequently, on the Effective Date the Transferee became a limited partner in the Partnership, with a capital contribution of EUR 1,407.23:

(i) Dover Street VII L.P.; (ii) Secondary Overflow Fund L.P.; (iii) HarbourVest Partners IX - Buyout Fund L.P.; (iv) HarbourVest Partners IX - Venture Fund L.P.; and (v) HarbourVest Partners IX - Credit Opportunities Fund L.P. ceased to be limited partners in the Partnership.
