Conditions of existence of the partnership:

- The insolvency (meaning the inability of the Limited Partner to pay its debts as they fall due), dissolution or liquidation, receivership or administration of or in relation to the Limited Partner (or the equivalent under any applicable insolvency law), the transfer of or other dealing with the Limited Partner's interest in the Partnership in accordance with Clause 15.1 of the Limited Partnership Agreement shall not operate to terminate the Partnership unless (as a result of such event) only one partner would remain in the Partnership and the trustee, receiver, liquidator, administrator or assignee of the insolvent or dissolved or other, as appropriate, Limited Partner shall not have the right to withdraw the balances on the Limited Partner's partnership accounts or require repayment of the Partner Loan, as defined in the Limited Partnership Agreement, otherwise than in accordance with that Agreement.
- The Partnership shall terminate upon the happening of any of the following events:
- i. the insolvency (meaning the inability of the General Partner to pay its debts as they fall due or its liabilities being in excess of his assets), dissolution or liquidation of the General Partner or the appointment of an administrator or receiver thereto (or the equivalent under any applicable insolvency law);
- ii. the agreement in writing of all the partners that the Partnership should terminate;
- iii. the distribution to the Limited Partner of all the Partnership Assets (as defined in the Limited Partnership Agreement) (except for the avoidance of doubt the Capital Contributions, as defined in the Limited Partnership Agreement); or
- iv. there being only one partner remaining.
