Pursuant to the terms of a Transfer Deed effective on 28 April 2008, Elsina Limited transferred all of the interest held by it in the Partnership to Consensus Introducers Limited. As a result Elsina Limited has ceased to be a limited partner of the Partnership and Consensus Introducers Limited has become a limited partner of the Partnership.

*f. Change in the sum contributed by a limited partner (see Note 3) (particulars of any increase in capital contributions must be provided at (h) overleaf)*

The capital contribution of GBP 500 made by Elsina Limited has been transferred to Consensus Introducers Limited on 28 April 2008. As a result Elsina Limited no longer has a capital contribution to the Partnership and the capital contribution of Consensus Introducers Limited is GBP 500. The total capital contributed to the Partnership by its limited partners is unchanged.
