

NOTES

- 1 This form is also to be used to notify changes in a limited partnership which is a partnership scheme (within the meaning given by section 253A(5) of the Financial Services and Markets Act 2000) for which an authorisation order has been made under section 261D of that Act ("an authorised partnership") The requirement to notify changes in partnership under section 9 of the Limited Partnerships Act 1907 has been modified for authorised partnerships by regulation 16(6) of the Collective Investment in Transferable Securities (Contractual Scheme) Regulation 2013
- 2 Changes brought about by death, transfer of interests, increase in the number of partners or change of name of any partner must be notified here In the case of an authorised partnership, any change in the general partner or in the name of the general partner must be notified here (no change in the limited partners or in the name of a limited partner is required to be notified)

Section (d) - Change in the partners or the name of any partner

Pavilion Trustees Limited (as the former managing trustee of LDC (St Pancras Way) Unit Trust) (the "**Former Trustee**") has transferred the whole of its interest in LDC (St Pancras Way) Management Limited Partnership (the "**Partnership**") to Sanne Trustee Services Limited (in its capacity as the managing trustee of LDC (St Pancras Way) Unit Trust) (the "**New Trustee**"). Accordingly, the Former Trustee has ceased to be a partner in the Partnership and the New Trustee has been admitted as the sole limited partner in the Partnership.

Section (f) - Sum contributed by any limited partner

The Former Trustee's total capital contribution to the Partnership was, immediately prior to the transfer of interest referred to in section (d) above, £2. Accordingly, upon the transfer of interest referred to in section (d) above, the New Trustee's total capital contribution as the sole limited partner in the Partnership was £2 and the Former Trustee ceased to have any interest in the Partnership.
