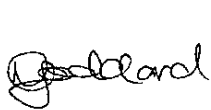

On 30 June 2020 Argentum Fondsinvesteringer AS, Argentum EIS AS, Bradbenken AS and Argentum NPEP AS transferred their limited partner commitments of: Argentum Fondsinvesteringer AS - SEK 112,421,751.75, Argentum EIS AS - SEK 1,428,24.25, Bradbenken AS - SEK 1,150,000, Argentum NPEP AS - SEK 24,855,052 in Accent Equity 2012 LP to Special Investment Fund eQ PE SF III (AIF) (the "New Investor"). At which point Argentum Fondsinvesteringer AS, Argentum EIS AS and Bradbenken AS ceased to be limited partners and the New Investor was admitted as a limited partner. Please note that Argentum NPEP AS only partially transferred its commitment and therefore remains a limited partner in Accent Equity 2012 LP with SEK 28,985,801.23 of commitment.
