

This form is also to be used to notify changes in a limited partnership which is a partnership scheme (within the meaning given by section 235A(5) of the Financial Services and Markets Act 2000) for which an authorisation order has been made under section 261D of that Act or a limited partnership which has been authorised under Regulation (EU) No 2015/760 of the European Parliament and of the Council of 29th April 2015 on European Long-term Investment Funds ("an authorised partnership"). The requirement to notify changes in partnerships under section 9 of the Limited Partnerships Act 1907 has been modified for authorised partnerships by regulation 16(6) of the Collective Investment in Transferable Securities (Contractual Scheme) Regulations 2013 and by regulation 9 of the European Long-term Investment Funds Regulations 2015.

#### APPENDIX 1

##### c) Change in partners or the name of any partner

On 28 FEBRUARY 2019, Kensington View Unit Trust (acting by its trustee Sanne Trustee Services Limited) transferred 0.01% of its limited partner interest in the Partnership to New KHS Limited. Kensington View Unit Trust ceased to be a limited partner of the Partnership in respect of that share and New KHS Limited's interest as a limited partner of Kensington View Limited Partnership has been increased.

On 28 FEBRUARY 2019, Kensington View Unit Trust (acting by its trustee Sanne Trustee Services Limited) transferred 99.9% of its limited partner interest in the Partnership to Arcade View Limited Partnership. Kensington View Unit Trust ceased to be a limited partner of the Partnership in respect of that share and Arcade View Limited has been admitted as a limited partner in the Partnership.

#### APPENDIX 2

##### g) The sum contributed by any limited partner

As a result of the first transfer noted in (c), Kensington View Unit Trust (acting by its trustee Sanne Trustee Services Limited) reduced its capital contribution from £67.11 to £67.04289 and New KHS Limited made a capital contribution of £0.06711.

As a result of the second transfer noted in (c), Kensington View Unit Trust (acting by its trustee Sanne Trustee Services Limited) reduced its capital contribution from £67.04289 to nil and Arcade View Limited made a capital contribution of £67.04289.
