To carry on the business of investing (with the general intention of holding investments for approximately four years or more from the date of acquisition) and monitoring the performance, and management, of such investments and in particular, but without limitation, to identify, research, negotiate, make, hold and realise investments (and to monitor the same) including the acquisition, sale and disposal of controlling or co-controlling equity or equity-related instruments issued by companies or undertakings or other entities, and the making of loans whether secured or unsecured to such companies, undertakings or other entities, with the principal objective of generating profit, and in particular, but without limitation, to co-invest in parallel in investments with the fund known as “EQT Mid Market Europe”

### **d. Change in the partners or name of a partner**

EQT Services (General Partner II) Limited has transferred 100% of its interest in the Partnership, including 100% of its capital contribution, to EQT Mid Market Europe (General Partner) Limited in its capacity as general partner of the Partnership, and consequently, EQT Services (General Partner II) Limited has ceased to be a limited partner in the Partnership

#### **e. Term or character of the partnership**

##### **Previous term**

The term of the Partnership shall continue for a period of ten years from its commencement date, provided that it shall terminate immediately upon

- (a) the written deed of both partners, or
- (b) the bankruptcy, insolvency, dissolution or liquidation of EQT Services (General Partner) Limited

##### **New term**

The term of the Partnership shall continue until such date as the affairs of the Partnership have been fully wound up and the partnership assets distributed amongst the partners in accordance with the provisions of the limited partnership agreement governing the Partnership. A liquidating trustee shall be appointed on the term date with a view to winding up the affairs of the Partnership.

#### **f. Change in the sum contributed by a limited partner**

The form LP5 previously filed with respect to the Partnership incorrectly referred to EQT Services (General Partner II) Limited making its capital contribution in pound sterling (the “**Incorrect Denomination**”). The correct denomination of EQT Services (General Partner II) Limited’s capital contribution was Euro, and all references to the Incorrect Denomination should accordingly be treated as references to Euro. Such form LP5 is otherwise correct and unaffected by the aforementioned error.

EQT Services (General Partner II) Limited has transferred 100% of its interest in the Partnership, including 100% of its capital contribution amounting to €100 00, to EQT Mid Market Europe (General Partner) Limited in its capacity as general partner of the Partnership, and consequently, EQT Services (General Partner II) Limited has ceased to be a limited partner in the Partnership.
