In 2010 we wrote to the above company, informing it of the requirement to file a Transitional Return However, we have not yet received a response, so we are now sending this letter to all secretaries and directors showing on our records for this company

On 1 October 2009, the Overseas Companies Regulations 2009 (SI No 2009/1801) introduced a number of changes including the introduction of a single 'UK establishment' regime. This means that Companies House will only register UK establishments. All places of business and branches registered before 1 October 2009 are deemed to be UK establishments from that date

To make this change effective all places of business and branches that were registered at Companies House prior to 1 October 2009 were required to deliver a Transitional Return (Form OS TN01) by 31 March 2010. A place of business or branch registered before 1 October 2009 that provides this additional information will meet the information requirements under the new UK establishment regime.

The introduction of a single UK establishment regime requires the allocation of these numbers to previously registered places of business.
