UPON APPLICATION by DANIEL JAMES MARK SMITH pursuant to the Insolvency (Northern Ireland) Order 1989 and the Insolvency Rules (Northern Ireland) 1991;

AND UPON READING the Grounding Affidavit of DANIEL JAMES MARK SMITH;

AND UPON READING the Supporting Affidavit of PETER MICHAEL ALLEN;

AND UPON HEARING the Solicitor for the Applicant and the Respondent consenting;

THE COURT DOES ORDER:

- 1 That pursuant to Article 31 of the Insolvency (Northern Ireland) Order 1989 and Paragraph 89 of Schedule B1 of the Insolvency (Northern Ireland) Order 1989 (the 1989 Order) that the Applicant be removed as Administrator in respect of each of the companies specified in Appendix 1 to this Order.
- 2 That pursuant to Article 32 and Paragraph 99 of Schedule B1 of the 1989 Order that the Applicant be discharged and released as Administrator in respect of the companies specified in Appendix 1 to this Order.
- 3 That the removals made pursuant to this Order shall take effect forthwith and without the requirement to hold meetings of creditors of the companies specified in Appendix 1 to this Order.
- 4 That the Applicant shall be released from all liability pursuant to the relevant Articles and Schedules of the 1989 Order in respect of his acts and omissions as Administrator in respect of each of the companies specified in Appendix 1 to this Order, such release to take effect in relation to each estate 28 days after the report to creditors in each case.
- 5 That the Applicant is not required to produce any progress reports on ceasing to act as Administrator of the companies specified in Appendix 1 to this Order.
- 6 That the terms of this Order shall be explained and notified to creditors of the companies specified in Appendix 1 to this Order when the next statutory or routine report is due, or earlier if the Respondent considers it appropriate to do so.
- 7 That there be liberty for the creditors of the companies specified in Appendix 1 to this Order, on reasonable grounds, to apply to vary or discharge this Order within 28 days of being given notice of its terms.
- 8 An Order that the costs of this application are costs in each of the individual administrations specified in Appendix 1 to this Order and are to be apportioned amongst them in equal shares, provided that if the costs which fall to be borne by any one of the companies exceeds 10% of the realisable assets within that estate, that that estate shall bear only the part of those apportioned costs as equals 10% of that particular estate's realisable assets.
