

1 Accounting policies

Jenkins No 2 Ltd (the "Company") is a company limited by shares and incorporated and domiciled in the UK.

These financial statements have been prepared in accordance with Financial Reporting Standard 102 *The Financial Reporting Standard* applicable in the UK and Republic of Ireland ("FRS 102") as issued in September 2016. The presentation currency of these financial statements is sterling.

The Company was dormant (within the meaning of section 1169 of the Companies Act 2006) throughout the year.
