UPON THE APPLICATION of Prudential Trustee Company Limited having its registered office at c/o L'Estrange & Brett, Bridge Street, Belfast, by originating summons dated 15 June 2005,

AND UPON READING the affidavit of Brian Henderson filed 15 June 2005, and the exhibit therein referred to,

AND UPON HEARING Counsel for the Applicant and Counsel for the Respondent,

AND the Applicant by his Counsel undertaking that in the case of a resolution for the winding up of the said companies becoming effective on or before 21 July 2005 or a petition for the winding up of the said companies being presented on or before 21 July 2005 on which an order for winding up shall be made and in case the said companies by its Liquidator or any unsecured creditor of the said companies shall within 28 days after the commencement of such voluntary winding up or the date of such order (whichever shall be the later) apply to this Court to discharge this order then the applicant will submit to the jurisdiction of this Court and will abide by any order that the Court may make (in case of the discharge of this present order) for rectification of the register of charges of the said companies kept by the Registrar of Companies by the removal there from of any registration effected under this present order.
