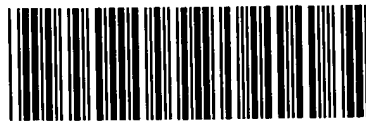

Business review



The company did not trade during the current or preceding period and has made neither a profit nor loss, nor any other recognised gain or loss.


For the year ending 31 December 2014 the company was entitled to exemption from audit under section 480 of the Companies Act relating to dormant companies.
