### 1. ACCOUNTING POLICIES

### Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

### Turnover

Turnover represents the net amounts invoiced to customers during the period less work in progress and net of value added tax.

### Pension costs

The company operates a defined contribution scheme for its employees under which the pension costs charged against profits represent the amount of contributions payable to the scheme for the period. Differences between contributions payable in the year and contributions actually paid are shown as either accruals or prepayments on the balance sheet.

### Dividends

The company recognises dividends in the period in which they are authorised.

### 3. ULTIMATE PARENT COMPANY

As at the year end Specsavers International Healthcare Limited was the ultimate parent company of Abbey Centre Visionplus Limited. Mr and Mrs Perkins have the controlling interest in the ordinary share capital of Specsavers International Healthcare Limited, the ultimate parent company. Specsavers International Healthcare Limited is a Guernsey registered company and its accounts are not available to the public.

The company's immediate parent company is Abbey Centre Specsavers Limited, a company registered in Northern Ireland.

### 4. RELATED PARTY TRANSACTIONS

During the year the company has conducted the following transactions with its ultimate parent company, Specsavers International Healthcare Limited and its subsidiaries, including Specsavers Optical Group Limited, its director. Specsavers Optical Group Limited is wholly owned by Specsavers International Healthcare Limited.

Sales £15,080 (2012: £16,303), Purchases of Goods £419,075 (2012: £409,295), Overhead Costs £238,226 (2012: £236,852) and Other Income £44,852 (2012: £36,145).

Included within trade creditors are balances with related parties which total £1,530 (2012: £Nil)

The balance due from the Group Treasury Company as at 31 August 2013 is £256,990 (2012: £231,470). This is held with Specsavers Finance (Guernsey) Limited, a fellow subsidiary of Specsavers International Healthcare Limited. Specsavers Finance (Guernsey) Limited is incorporated in Guernsey and provides treasury services to the company and other Specsavers Group companies.

### 5. POST BALANCE SHEET EVENTS

Subsequent to the year ended 31 August 2013, the company proposed and paid a dividend on its Ordinary shares of £2,968 (2012: £220,000) to its immediate parent, Abbey Centre Specsavers Limited. These financial statements do not reflect this dividend, which will be accounted for in the shareholders' equity as an appropriation of retained earnings in the year ended 31 August 2014.
