

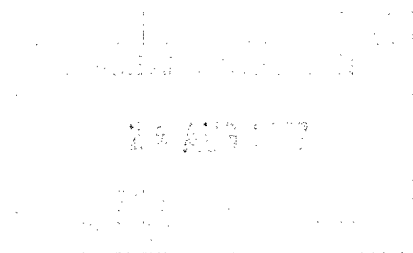

Notes to the abbreviated financial statements for the year ended 31 October 2006

1. Accounting policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

1.1. Accounting convention

The accounts are prepared under the historical cost convention and comply with the Financial Reporting Standard for Smaller Entities (effective January 2005) of the Accounting Standards Board, as promulgated by the Institute of Chartered Accountants in Ireland.

1.2. Turnover

Turnover represents the total invoice value, excluding value added tax, of sales made during the year.

1.3. Tangible fixed assets and depreciation

Depreciation is provided at rates calculated to write off the cost less residual value of each asset over its expected useful life, as follows:
