1 Definitions and interpretation

1.1 Definitions

In this Deed:

Affiliate means, in relation to a person, a Subsidiary of that person, a Holding Company of that person or any other Subsidiary of that Holding Company, in each case, from time to time

Business Day means a day (other than a Saturday or Sunday) on which banks are open for general business in London

CA 1911 means the Conveyancing Act 1911

CALPA 1881 means the Conveyancing and Law of Property Act 1881

Event of Default means any event of default (howsoever defined) under any Finance Document and any failure by the Chargor to satisfy any demand for payment under any Finance Document

Finance Document means this Deed, any document governing or evidencing the terms of the Secured Liabilities and any other document designated as a Finance Document by Santander and the Chargor

Fixtures means in respect of any Secured Property, all fixtures and fittings (including trade fixtures and fittings) and fixed plant and machinery now or at any time after the date of this Deed on that Secured Property

Holding Company means, in relation to a person, any person in respect of which it is a Subsidiary

Insurance Policies means all policies of insurance present and future relating to the Secured Assets in which the Chargor has an interest (other than policies in respect of third party liability) together with all monies payable in respect of those policies

Occupational Lease means any agreement for lease (or for licence) or any occupational lease or licence to which a Secured Property may be subject from time to time

Rental Income means the aggregate of all amounts paid or payable to or for the account of the Chargor in connection with the letting, licence or grant of other right or use or occupation of any part of any Secured Property

Secured Assets means all of the assets and undertaking of the Chargor the subject of any security created by, under or supplemental to, this Deed in favour of Santander

Secured Liabilities means all monies and liabilities now or after the date of this Deed due, owing or incurred by the Chargor to any Secured Party whatsoever, in any manner and in any currency or currencies and whether present or future, actual or contingent, whether incurred solely or jointly with any other person and whether as principal or surety, together with all interest accruing on such monies and liabilities and all costs, charges and expenses incurred by any Secured Party, except for any obligation which, if it were included here, would constitute unlawful financial assistance, or its equivalent in any other jurisdiction

Secured Party means Santander UK plc and each of its Affiliates

Secured Property means at any time the Properties and all other freehold or leasehold property which is subject to any security created by, under or supplemental to this Deed

Security Period means the period beginning on the date of this Deed and ending on the date on which Santander is satisfied that the Secured Liabilities have been irrevocably and unconditionally satisfied in full and all facilities made available by any Secured Party to the Chargor have been cancelled

Subsidiary means a subsidiary undertaking within the meaning of section 1162 of the Companies Act 2006

VAT means value added tax at the rate in force for the time being

1.2 Administration

Any reference in this Deed, or any other Finance Document entered into under or in connection with it, to:

- (a) the making of an administration order shall be treated as including a reference to the appointment of an administrator under paragraph 15 (by the holder of a qualifying floating charge in respect of the Chargor's assets) or 23 (by the Chargor or the directors of the Chargor) of Schedule B1 to the IO 1989 or any steps taken toward such order or appointment; or
- (b) making an application for an administration order by petition shall be treated as including a reference to making an administration application to the court under Schedule B1 to the IO 1989, appointing an administrator under paragraph 15 or 23 of that Schedule, or giving notice under paragraph 16 or 27 of that Schedule of intention to appoint an administrator or any steps taken towards such application or notice.

1.3 Interpretation

- (a) Unless a contrary indication appears, a reference in this Deed to:
 - (i) Santander, any Affiliate of Santander, any Secured Party, the Chargor, or any other person shall be construed so as to include its successors in title, permitted assigns and permitted transferees and, in the case of Santander, any person for the time being appointed as security trustee for the Secured Parties;
 - (ii) assets includes present and future properties, revenues and rights of every description (including any right to receive such revenues);
 - (iii) a Finance Document or any other agreement or instrument is a reference to that Finance Document or other agreement or instrument as amended, novated, supplemented or restated (however fundamentally) or replaced;
 - (iv) a person includes any individual person, firm, company, corporation, government, state or agency of a state or any association, trust, joint venture, consortium or partnership (whether or not having separate legal personality) or any other entity or body of any description;
 - (v) a regulation includes any regulation, rule, official directive, request or guideline (whether or not having the force of law but if not having the force of law, then being a type with which persons to which it applies customarily comply) of any governmental, intergovernmental or supranational body, agency, department or of any regulatory, self-regulatory or other authority or organisation;
 - (vi) a provision of law is a reference to a provision of any treaty, legislation, regulation, decree, order or by-law and any secondary legislation enacted under a power given by that provision, as amended, applied or re-enacted or

replaced (whether with or without modification) whether before, on or after the date of this Deed:

- (vii) a time of day is a reference to Belfast time; and
- (viii) dispose includes any sale, lease, licence, transfer or loan.
- (b) Clause and schedule headings are for ease of reference only.
- (c) Any word importing the singular shall include the plural and vice versa.
- (d) An Event of Default is continuing if it has not been waived to the satisfaction of Santander.
- (e) A term defined in this Deed has the same meaning when used in any notices, acknowledgements or other documents issued under or in connection with this Deed.

2 Covenant to pay

The Chargor covenants with Santander as security trustee for itself and each Secured Party to pay and discharge the Secured Liabilities when they become due for payment and discharge.

3 Charging provisions

3.1 General

All security created by the Chargor under this Deed is a continuing security for the payment and discharge of the Secured Liabilities, is granted as legal and beneficial owner and as registered owner or the person entitled to be registered owner in respect of all the right, title and interest (if any), present and future, of the Chargor in and to the relevant Secured Asset and is granted in favour of Santander as security trustee for itself and each Secured Party.

3.2 Mortgages

The Chargor hereby GRANTS, CONVEYS, TRANSFERS AND DEMISES unto Santander ALL THAT AND THOSE its freehold and leasehold lands, hereditaments, premises, property and all chattels, buildings and Fixtures both present and future, including, without prejudice to the generality of the foregoing, the Properties, particulars of which are specified in Schedule 1, title to which is not registered or registerable in the Land Registry of Northern Ireland pursuant to the provisions of the Land Registration Act (Northern Ireland) 1970 and all chattels both present and future, including its interest in all buildings, fixtures (including, without limitation, trade fixtures) and its fixed plant and machinery from time to time thereon TO HOLD the same as to so much thereof as is of freehold tenure unto Santander in fee simple and as to so much thereof as is of leasehold tenure unto Santander for the residue of the respective terms of years for which the Chargor from time to time holds the same less the last three days of each such term. subject to the equity of redemption as may for the time being be subsisting in the said property PROVIDED that the Chargor hereby declares that it shall henceforth stand possessed of such of the said property as is of leasehold tenure for the last three days or respective last days of the term or terms of years for which the same is held by it, and for any further or other interest which it now has or may hereafter acquire or become entitled to in the same or any part thereof by virtue of any Act or Acts of Parliament or otherwise howsoever, in trust for Santander and to be conveyed assigned or otherwise dealt with whether to Santander or its nominee or otherwise as Santander shall direct but subject to the same equity of redemption as may for the time being be subsisting in the said property, and the Chargor further agrees that (subject as aforesaid)

Santander shall be entitled to the custody of all the title deeds of the said property, and Santander hereby further authorises Santander as mortgagee during the continuance of this security to remove it or any other person from being a trustee in respect of the trust hereinbefore declared and to appoint Santander or any other person or persons to be a trustee or trustees in respect of the said property, and whereupon to make a declaration vesting all and any of its estate and interest in the said property in such new trustee or trustees, and so (but without prejudice to the generality of the foregoing) that any such trustee or trustees, may be any Receiver or Receivers of the said property appointed by Santander under the powers herein contained PROVIDED FURTHER that the Chargor doth hereby irrevocably appoint the Secretary for the time being of Santander to be its attorney, in its name and on its behalf, and as its act and deed to sign seal and deliver and otherwise perfect every or any Deed of Conveyance of the leasehold reversion which may be desired by Santander, in order to vest in Santander or in any person or persons in trust as agent for Santander, subject as aforesaid, or in any purchaser of the said property or any part thereof, the said leasehold reversion and any further or other interest which the Chargor now has or may hereafter acquire or become entitled to in the said leasehold premises or any part thereof by virtue of any Act or Acts of Parliament or otherwise howsoever.

3.3 Assignments

- (a) The Chargor assigns:
 - (i) the Relevant Agreements;
 - (ii) all Rental Income and all other sums payable under any Occupational Lease;
 and
 - (iii) the Insurance Policies.
- (b) The Chargor shall remain liable to perform all its obligations under each Relevant Agreement and each Insurance Policy.

3.4 First fixed charges

The Chargor charges by way of first fixed charge:

- (a) all interests and estates in any freehold or leasehold property now or subsequently owned by it including (without prejudice to the generality of the foregoing) the Properties particulars of which are set out in Schedule 1, title to which is registered or registrable in the Land Registry of Northern Ireland and, in each case, all buildings and Fixtures on each such property;
- (b) the proceeds of sale of the Secured Property and all licences to enter on or use any Secured Property;
- (c) the benefit of all other agreements, instruments and rights relating to the Secured Property;
- (d) all monies from time to time standing to the credit of each Rent Account; and
- (e) to the extent that any assignment in clause 3.3 is ineffective as an assignment, the assets referred to in that clause.

3.5 Small company moratorium

If the Chargor is an eligible company within the meaning of paragraphs 2 to 4 (inclusive) of Schedule A1 to the IO 1989, then the obtaining of a moratorium, including any preliminary decision, or investigation in terms of paragraph 53 to Schedule A1 of the IO 1989 shall not cause any floating charge created by this Deed to crystallise into a fixed charge, nor cause restrictions which would not otherwise apply to be imposed on the disposal of its property and assets by the Chargor.

4 Negative pledge

4.1 The Chargor shall not (without the prior written consent of Santander) create or permit to subsist any security over any of the Secured Assets.

4.2 The Chargor shall not:

- (a) sell, transfer or otherwise dispose of any of the Secured Assets on terms whereby they are or may be leased to or re-acquired by the Chargor or any Affiliate of the Chargor; or
- (b) enter into any other preferential arrangement having a similar effect,

in circumstances where the arrangement or transaction is entered into primarily as a method of raising finance or of financing the acquisition of an asset.

5 Restrictions on disposals

The Chargor shall not (without the prior written consent of Santander) enter into a single transaction or a series of transactions (whether related or not) and whether voluntary or involuntary to sell, lease, transfer or otherwise dispose of any Secured Assets.

6 Further assurance

- 6.1 The Chargor shall promptly do all such acts and execute all such documents (including, without limitation, any assignment, transfer, conveyance, assurance, mortgage, charge, notice and instruction) as Santander may specify (and in such form as Santander may require) in favour of Santander or its nominee(s) to:
 - (a) create, perfect, protect and maintain the security created or intended to be created under or evidenced by this Deed or for the exercise of any rights, powers and remedies of Santander provided by or pursuant to this Deed or by law;
 - (b) to confer on Santander security over any property and assets of the Chargor located in any jurisdiction equivalent or similar to the security intended to be conferred by or pursuant to this Deed; and/or
 - (c) (if an Event of Default is continuing) to facilitate the realisation of the assets which are, or are intended to be, the subject of the security created by or under this Deed.
- 6.2 Any document required to be executed by the Chargor under this clause 6 will be prepared at the cost of the Chargor.

7 Land Registry

7.1 Application for inhibition

(a) In relation to land and buildings situated in Northern Ireland title to which is registered or is to be registered at the Land Registry of Northern Ireland, the Chargor consents to an application being made to the Registrar for registration of an inhibition on the folios of all present and future registered freehold or leasehold property of the Chargor (and any unregistered properties subject to compulsory first registration at the date of this Deed) on the following terms:

No disposition of the registered land by the registered owner of the registered land is to be registered without a written consent signed by the registered owner for the time being of the Direct Legal Charge dated _______ originally registered in favour of Santander UK Plc, whose address for the service of notice is Santander UK Plc, Operations Middle Office Securities, Ops Block, Ground Floor Area 3A, Bridle Road, Bootle, Merseyside, L30 4GB.

(b) The Chargor confirms that so far as any of the Secured Property is unregistered, such land is not affected by any burdens specified in Part 1 of Schedule 5 to the Land Registration Act (Northern Ireland) 1970 (the "Overriding Interests").

7.2 Further advances

If Secured Parties are, subject to the terms of the Finance Documents, under an obligation or otherwise agree to make further advances to the Chargor, this security has been made for securing such further advances.

7.3 Future property

If the Chargor acquires (or intends to acquire) any freehold or leasehold or other interest in property after the date of this Deed it must:

- notify Santander immediately of such acquisition or its intention to acquire such property;
- (b) immediately on request by Santander and at the cost of the Chargor, execute and deliver to Santander, a legal mortgage in favour of Santander (as security trustee for itself and each Secured Party) of such property in such form as Santander may require;
- (c) obtain such consents as are required for the security referred to in this clause 7.3;
- (d) if the title to such freehold or leasehold property is registered at the Land Registry of Northern Ireland or required to be so registered, to give the Land Registry of Northern Ireland written notice of the security; and
- (e) if applicable, ensure that the security is correctly noted on the relevant folio(s) for that title at the Land Registry of Northern Ireland.

8 Notices of assignments and charges

8.1 Relevant Agreements

(a) Immediately upon request by Santander, the Chargor shall give notice in the form specified in part 1 (Form of notice of assignment) of schedule 4 to each counterparty to each Relevant Agreement other than an Occupational Lease (including, for the avoidance of doubt, any Relevant Agreement coming into existence after the date of this Deed) that the Chargor has assigned to Santander all its right, title and interest in the Relevant Agreement:

(b) The Chargor shall use reasonable endeavours to procure that the recipient of each such notice acknowledges that notice in substantially the form specified in part 2 (Form of acknowledgement) of schedule 4 within 5 Business Days of that notice being given.

8.2 Rental Income

- (a) Immediately upon request by Santander, the Chargor shall give notice in the form specified in part 1 (Form of notice of assignment) of schedule 5 to each tenant under each Occupational Lease (including, for the avoidance of doubt, any Occupational Lease coming into existence after the date of this Deed) that the Chargor has assigned to Santander all its right, title and interest in the Rental Income and other monies payable under that Occupational Lease.
- (b) The Chargor shall use reasonable endeavours to procure that the recipient of each such notice acknowledges that notice in substantially the form specified in part 2 (Form of acknowledgement) of schedule 5 within 5 Business Days of that notice being given.

8.3 Insurance Policies

- (a) Immediately upon request by Santander, the Chargor shall give notice in the form specified in part 1 (Form of notice of assignment) of schedule 6 to each insurer under each Insurance Policy (including, for the avoidance of doubt, any Insurance Policy coming into existence after the date of this Deed) that the Chargor has assigned to Santander all its right, title and interest in that Insurance Policy.
- (b) The Chargor shall use reasonable endeavours to procure that the recipient of each such notice acknowledges that notice in substantially the form specified in part 2 (Form of acknowledgement) of schedule 6 within 5 Business Days of that notice being given.

8.4 Rent Accounts

- (a) Immediately upon request by Santander, the Chargor shall give notice in the form specified in part 1 (Form of notice of charge) of schedule 7 to the financial institution at which each Rent Account is held (including, for the avoidance of doubt, any Rent Account opened after the date of this Deed) that the Chargor has created a fixed charge over the balance standing to the credit of that Rent Account.
- (b) The Chargor shall use reasonable endeavours to procure that the recipient of each such notice acknowledges that notice in substantially the form specified in part 2 (Form of acknowledgment) of schedule 7 within 5 Business Days of that notice being given.

9 Undertakings

The Chargor undertakes to Santander that during the Security Period:

9.1 Real property

(a) Access

It will allow Santander and such person or persons as Santander nominates to enter on any part of the Secured Property.

(b) Repair

- (i) It shall keep the Secured Property in good and substantial repair and condition and decorative order.
- (ii) It shall repair any defect or damage to any of the Secured Property promptly and if it fails to do so Santander may, but shall not be obliged to, do so.

(c) Planning

It shall not do or allow to be done or fail to do anything which may infringe or contravene any statute or regulation governing or controlling the use or development of the Secured Property, nor apply for planning permission.

(d) Planning directions

- (i) Within 5 Business Days of receipt by it of any notice or order (Direction) served on or issued to it by any local or other authority in respect of any part of the Secured Property, it shall give full particulars of the Direction to Santander and, if requested to do so by Santander, produce the Direction or a copy of it to Santander.
- (ii) It shall advise Santander of all steps taken or proposed to be taken by it from time to time to comply with the terms of the Direction and shall take all necessary steps to comply with the Direction.
- (iii) It shall at the request of Santander (but at the cost of the Chargor) make or join with Santander in making such objections, representations against, appealing against or in respect of any proposal contained in the Direction as Santander shall deem necessary or desirable in order to protect Santander's interests.

(e) Development

It shall not, without Santander's prior written consent, carry out any development on any part of the Secured Property nor change the use of any part of the Secured Property.

(f) Deposit of title deeds

It shall deposit with Santander all deeds and documents of title relating to the Secured Property.

(g) Outgoings

It will punctually pay and indemnify Santander and any Receiver against all present and future rents, rates, taxes, assessments and outgoings of whatsoever nature imposed on or payable in respect of the Secured Property or any part of it or payable by the owner or occupier of it.

(h) Investigation of title

On request by Santander, it shall grant Santander or its advisers (at the cost of the Chargor) all facilities within its power to enable Santander or its advisers or delegates

to carry out such investigations of title to and enquiries into the Secured Property or other Secured Assets as may be carried out by a prudent mortgagee or chargee.

(i) Overriding interests

It shall not, without the prior written consent of Santander, enter into any onerous or restrictive obligations affecting the whole or any part of any Secured Property or create or permit to arise any Overriding Interests, easement or right whatever in or over the whole or any part of any Secured Property.

9.2 Leases

(a) Lease and covenant compliance

It shall:

- perform all its obligations, covenants and stipulations contained in any lease or agreement for lease under which it holds an interest in a Secured Property or to which any of the Secured Property is subject;
- (ii) properly perform (and indemnify Santander and each Receiver for any breach
 of) any covenants and stipulations of whatsoever nature affecting any of the
 Secured Property;
- (iii) not make any election or take any other action so as to alter the treatment of any Occupational Lease for the purposes of value added tax; and
- (iv) immediately notify Santander of any notice received by it under section 14 of the CALPA 1881 or any proceedings commenced or steps taken against it for the forfeiture of any lease under which it holds an interest in a Secured Property.

(b) No variation to lease

It shall not without the prior written consent of Santander alter or vary or agree to alter or vary the terms of any lease under which it holds any Secured Property or any lease to which any Secured Property is subject.

(c) No surrender or termination

It shall not surrender or otherwise terminate any lease under which it holds a Secured Property or terminate, forfeit or accept a surrender of any lease to which any Secured Property is subject.

(d) Compliance by tenants

It shall use reasonable endeavours to procure that each tenant under an Occupational Lease complies with the terms of that Occupational Lease in a proper and timely manner.

(e) Lease or right to occupy

It will not without the prior written consent of Santander:

- grant any lease or tenancy or exercise any other power of leasing of the whole
 or part of any Secured Property; or
- (ii) grant any person any contractual licence or the right to occupy any Secured Property or part with possession of it.

(f) Forfeiture

It shall not do or permit anything which may render any lease or agreement for lease under which it holds an interest in a Secured Property, or to which the Secured Property is subject, liable to forfeiture or otherwise determinable.

9.3 Insurance

- (a) It shall keep its business and assets insured at all times with reputable insurers in a form and amount and against such risks (including insurance for any environmental risks) as Santander considers a prudent company carrying on the same or substantially similar business as the Chargor would effect.
- (b) It shall pay all premiums by their due date for payment and do all other things necessary to keep all of the policies of insurance in which it has an interest in full force and effect.
- (c) It shall not do or permit to be done anything to render the insurance void or voidable
- (d) Where required in writing by Santander, it shall ensure that:

(i)

- (A) Santander is named as composite insured in respect of its own separate insurable interest under each policy of insurance (other than public liability and third party liability insurances where clause 9.3(d)(i)(B) shall apply) maintained by it or any person on its behalf in accordance with clause 9.3(a) but without Santander having any liability for any premium in relation to such policy of insurance;
- in respect of public liability or third party liability insurances the name of Santander be noted on each policy of insurance as mortgagee; and
- (ii) each policy of insurance shall contain a standard mortgagee clause whereby, among other things, the insurance shall not be vitiated or avoided as against a mortgagee notwithstanding that it could otherwise be so against the Chargor.
- (e) It shall ensure (save where Santander agrees otherwise in writing) that each policy of insurance shall contain a provision to the effect that the insurance shall not be invalidated as against Santander for non-payment of any premium due without the insurer first giving to Santander not less than 10 Business Days' written notice.
- (f) If the Chargor shall be in default of effecting or maintaining insurances or in producing any such policy or receipt to Santander on demand, Santander may take out or renew such insurances in any sum which Santander may think expedient and all monies expended and costs incurred by Santander under this provision shall be for the account of the Chargor.

- (g) Subject to any statutory or contractual restriction arising before the date of this Deed, at the option of Santander, any proceeds of insurance shall be applied towards the repayment of the Secured Liabilities.
- (h) Subject to clause 9.3(g) above with the prior written consent of Santander, all proceeds of insurance shall be applied towards replacing or reinstating the property in respect of which the proceeds are received.
- (i) It shall procure that there is given to Santander copies of the insurances in which it has an interest, and such other information in connection with them as Santander may reasonably require. It will notify Santander in writing of all renewals, material variations and cancellations of policies made or, to its knowledge, threatened or pending.
- 9.4 Unless agreed otherwise in writing by Santander, it must procure that the policies of insurance comply with the following requirements:
 - (a) each such policy must contain:
 - (i) a non-invalidation and non-vitiation clause under which the policy will not be vitiated or avoided as against any insured party as a result of any circumstances beyond the control of that insured party or any misrepresentation, non-disclosure, or breach of any policy term or condition, on the part of any insured party or any agent of any insured party;
 - (ii) a waiver of the rights of subrogation of the insurer as against the Chargor,
 Santander and the tenants of any Secured Property; and
 - (iii) a loss payee clause in such terms as Santander may reasonably require in respect of insurance claim payments otherwise payable to the Chargor;
 - (b) the insurers must give at least 30 days' notice (or a shorter period with Santander's prior written consent) to Santander if any insurer proposes to repudiate, rescind or cancel any policy of insurance, to treat it as avoided in whole or in part, to treat it as expired due to non-payment of premium or otherwise decline any valid claim under it by or on behalf of any insured party and must give the opportunity to rectify any such non-payment of premium within the notice period; and
 - (c) the Chargor must be free to assign all amounts payable to it under each of its policies of insurance and all its rights in connection with those amounts in favour of Santander.
- 9.5 It must use all reasonable endeavours to ensure that Santander receives copies of the policies of insurance, receipts for the payment of premiums for those policies and any information in connection with those policies and claims under them which Santander may reasonably require.
- 9.6 It must promptly notify Santander of:
 - (a) the proposed terms of any future renewal of any of the policies of insurance;
 - (b) any amendment, supplement, extension, termination, avoidance or cancellation of any
 of the policies of insurance made or, to its knowledge, threatened or pending;
 - (c) any claim, and any actual or threatened refusal of any claim, under any of the policies of insurance; and

(d) any event or circumstance which has led or may lead to a breach by the Chargor of any term of this clause.

9.7 It must:

- (a) comply with the terms of the policies of insurance;
- not do or permit anything to be done which may make void or voidable any of the policies of insurance;
- (c) comply with all reasonable risk improvement requirements of its insurers;
- ensure that each premium for the policies of insurance is paid promptly and in any event prior to the commencement of the period of insurance for which that premium is payable; and
- (e) ensure that all other things necessary are done so as to keep each of the policies of insurance in force.

9.8 Criminal Damage Compensation

In the event of the Secured Property or any part thereof being destroyed or damaged by any circumstances giving rise to a claim under the Criminal Damage (Compensation) (Northern Ireland) Order 1977 (as amended), it shall immediately institute a claim under said Order and serve a copy of the documentation of the claim on Santander and take all steps required to obtain payment of the maximum compensation payable under the said Order and either apply all compensation paid thereunder in rebuilding and reinstating the Secured Property making good any deficiency out of the its own monies or if Santander so requires assign its rights under any claim and any monies payable thereunder and pay any such deficiency whereupon its liability to make good and reinstate the Secured Property so damaged under any covenant in this Deed shall be deemed satisfied.

9.9 General

It shall not do or cause or permit to be done anything which may in any way materially depreciate, jeopardise or otherwise prejudice the value to Santander or any other Secured Party of the security created by or under this Deed.

10 Power to remedy

- 10.1 If the Chargor fails to comply with any of the undertakings set out in clause 9 (Undertakings) it shall allow and irrevocably authorises Santander and/or such persons as it shall nominate to take such action on its behalf as shall be necessary to ensure that it complies with those undertakings.
- 10.2 If the Chargor fails to perform any obligation or other covenant affecting the Secured Property or other Secured Asset, the Chargor shall permit Santander or its agents and contractors to enter on the Secured Property, to comply with or object to any notice served on the Chargor relating to the Secured Property or other Secured Asset and to take any action Santander may reasonably consider expedient to prevent or remedy any breach of any such term or to comply with or object to any such notice.
- 10.3 The Chargor shall on demand indemnify Santander against any cost, loss or liability incurred by it in taking any of the steps referred to in this clause 10.

11 Security power of attorney

The Chargor, by way of security, irrevocably and severally appoints Santander, each Receiver and any of their delegates or sub-delegates to be its attorney to take any action which the Chargor is obliged to take under this Deed. The Chargor ratifies and confirms whatever any attorney does or purports to do pursuant to its appointment under this clause 11.

12 Enforcement of security

12.1 When security is enforceable

On the occurrence of any Event of Default which is continuing, the security created by and under this Deed is immediately enforceable.

12.2 Acts of enforcement

Santander may, at its absolute discretion, at any time after the security created by or under this Deed is enforceable:

- enforce all or any part of the security created by or under this Deed in any manner it sees fit;
- (b) exercise its rights and powers conferred upon mortgagees by the CALPA 1881 and CA 1911, each as varied and extended by this Deed, and rights and powers conferred on a Receiver by this Deed, whether or not it has taken possession or appointed a Receiver to any of the Secured Assets;
- (c) appoint a Receiver to all or any part of the Secured Assets;
- (d) appoint an administrator in respect of the Chargor and take any steps to do so;
- (e) exercise its power of sale under section 19 of the CALPA 1881 and the powers incident thereto set out in section 4 of the CA 1911 (as such powers are amended by this Deed); or
- (f) if permitted by law, appoint an administrative receiver in respect of the Chargor.

12.3 Statutory powers - general

- (a) For the purposes of all powers implied by statute, the Secured Liabilities are deemed to have become due and payable on the date of this Deed.
- (b) Section 20 of the CALPA 1881 and section 17 of the CALPA 1881 do not apply to the security constituted by or under this Deed.
- (c) The statutory powers of leasing conferred on Santander are extended so that, without the need to comply with any provision of section 18 of CALPA 1881 or section 3 of the CA 1911, Santander is empowered to lease and make agreements for lease at a premium or otherwise, accept surrenders of leases and grant options or vary or reduce any sum payable under any leases or tenancy agreements as it may think fit.
- (d) Each Receiver and Santander is entitled to all the rights, powers, privileges and immunities conferred by the CALPA 1881, CA 1911 and the IO 1989 on mortgagees and Receivers.

12.4 Mortgagee in possession - no liability

Neither Santander nor any Receiver will be liable, by reason of entering into possession of a Secured Asset, to account as mortgagee in possession or for any loss on realisation or for any default or omission for which a mortgagee in possession might otherwise be liable.

12.5 Redemption of prior mortgages

At any time after the security created by or under this Deed has become enforceable, Santander may, at the sole cost of the Chargor (payable to Santander on demand):

- (a) redeem any prior form of security over any Secured Asset; and/or
- (b) procure the transfer of that security to itself; and/or
- (c) settle and pass the accounts of any prior mortgagee, chargee or encumbrancer which once so settled and passed shall be conclusive and binding on the Chargor.

13 Receiver

13.1 Appointment of Receiver

(a)

- (i) At any time after any security created by or under this Deed is enforceable, Santander may appoint a Receiver to all or any part of the Secured Assets in accordance with clause 12.2(c) (Acts of enforcement).
- (ii) At any time, if so requested in writing by the Chargor, without further notice, Santander may appoint a Receiver to all or any part of the Secured Assets as if Santander had become entitled under the CALPA 1881 to exercise the power of sale conferred under the CALPA 1881.
- (b) Any Receiver appointed under this Deed shall be the agent of the Chargor and the Chargor shall be solely responsible for his acts or defaults and for his remuneration and liable on any contracts or engagements made or entered into by him and in no circumstances whatsoever shall Santander be in any way responsible for any misconduct, negligence or default of the Receiver.
- (c) Where the Chargor is an eligible company within the meaning of paragraphs 2 to 4 (inclusive) of Schedule A1 to the IO 1989:
 - (i) obtaining a moratorium; or
 - (ii) anything done with a view to obtaining a moratorium including any preliminary decision or investigation in terms of paragraph53 of Schedule A1 to the IO 1989,

shall not be grounds for appointment of a Receiver.

13.2 Removal

Santander may by written notice remove from time to time any Receiver appointed by it (subject to the provisions of article 55 of the IO 1989 in the case of an administrative receiver) and,

whenever it may deem appropriate, appoint a new Receiver in the place of any Receiver whose appointment has terminated.

13.3 Powers of Receiver

- (a) In addition to those conferred by the CALPA 1881 on any Receiver appointed under that Act, each Receiver has, and is entitled to exercise, all of the rights, powers and discretions set out in this clause 13.3.
- (b) If there is more than one Receiver holding office at the same time, unless the document appointing him states otherwise, each Receiver may exercise all of the powers conferred on a Receiver under this Deed or under the IO 1989 individually and to the exclusion of any other Receivers.
- (c) A Receiver of the Chargor has all the rights, powers and discretions of an administrative receiver under the IO 1989.
- (d) A Receiver may:
 - (i) in the name of the Chargor:
 - (A) do all other acts and things which he may consider expedient for realising any Secured Asset; and
 - (B) exercise in relation to any Secured Asset all the powers, authorities and things which he would be capable of exercising if he were its absolute beneficial owner;
 - (ii) raise and borrow money (either unsecured or on the security of any Secured Asset, either in priority to the security constituted by this Deed or otherwise) on any terms and for whatever purpose which he thinks fit. No person lending that money need enquire as to the propriety or purpose of the exercise of that power or to check the application of any money so raised or borrowed;
 - (iii) carry on the business of the Chargor as he thinks fit and, for the avoidance of doubt, a Receiver may apply for such authorisations as he considers in his absolute discretion appropriate;
 - settle, adjust, refer to arbitration, compromise and arrange any claims, accounts, disputes, questions and demands with or by any person who is or claims to be a creditor of the Chargor or relating in any way to any Secured Asset;
 - (v) delegate his powers in accordance with clause 14 (Delegation);
 - (vi) for the purposes of this Deed, as he thinks appropriate, on behalf of the Chargor or for itself as Receiver, appoint and discharge managers, officers, agents, accountants, servants, workmen and others upon such terms as to remuneration or otherwise as he may think proper and may discharge any such persons appointed by the Chargor;
 - (vii) let any Secured Asset for any term and at any rent (with or without a premium) which he thinks proper and may accept a surrender of any lease or tenancy of

- any Secured Assets on any terms which he thinks fit (including the payment of money to a lessee or tenant on a surrender);
- (viii) bring, prosecute, enforce, defend and abandon all actions, suits and proceedings or submit to arbitration or any form of alternative dispute resolution in the name of the Chargor in relation to any Secured Asset as he considers expedient;
- (ix) take immediate possession of, get in and collect any Secured Asset;
- (x) in each case as he may think fit:
 - (A) make and effect all repairs and insurances and do all other acts which the Chargor might do in the ordinary conduct of its business be they for the protection or for the improvement of the Secured Assets;
 - (B) commence and/or complete any building operations on the Secured Property or other Secured Asset; and
 - apply for and maintain any planning permission, building regulation approval or any other permission, consent or licence;
- give valid receipts for all monies and execute all assurances and things which may be expedient for realising any Secured Asset;
- (xii) sell, exchange, convert into monies and realise any Secured Asset by public auction or private contract in any manner and on any terms which he thinks proper. The consideration for any such transaction may consist of cash, debenture or other obligations, shares, stock or other valuable consideration and any such consideration may be payable in a lump sum or by instalments spread over such period as he thinks fit. Fixtures and any plant and machinery annexed to any part of the Secured Property may be severed and sold separately from the property containing them without the consent of the Chargor;
- (xiii) form a Subsidiary of the Chargor and transfer to that Subsidiary any Secured Asset;
- (xiv) without restriction sell, let or lease, or concur in selling, letting or leasing, or vary the terms of, determine, surrender or accept surrenders of, leases or tenancies of, or grant options and licences over or otherwise dispose of or deal with, all or any part of the Secured Assets without being responsible for loss or damage, and so that any such sale, lease or disposition may be made for cash payable by instalments, loan stock or other debt obligations or for shares or securities of another company or other valuable consideration;
- (xv) form and promote, or concur in forming and promoting, a company or companies to purchase, lease, licence or otherwise acquire interests in all or any of the Secured Assets or otherwise, arrange for such companies to trade or cease to trade and to purchase, lease, license or otherwise acquire all or any of the Secured Assets on such terms and conditions whether or not including payment by instalments secured or unsecured as he may think fit;

- (xvi) redeem any prior security and settle and pass the accounts of the person entitled to the prior security so that any accounts so settled and passed shall (subject to any manifest error) be conclusive and binding on the Chargor and the money so paid shall be deemed to be an expense properly incurred by the Receiver;
- (xvii) purchase or acquire any land and purchase, acquire or grant any interest in or right over land;
- (xviii) implement or continue the development of (and obtain all consents required in connection therewith) and/or complete any buildings or structures on, any real property comprised in the Secured Property and do all acts and things incidental to the Secured Property;
- (xix) on behalf of the Chargor and without consent of or notice to the Chargor exercise all the powers conferred on a landlord or a tenant by any legislation from time to time in force in any relevant jurisdiction relating to rents or agriculture in respect of any part of the Secured Property;
- (xx) make calls conditionally or unconditionally on the members of the Chargor in respect of uncalled capital;
- (xxi) make, exercise or revoke any value added tax option to tax as he thinks fit; and
- (xxii) do all other acts and things including without limitation, signing and executing all documents and deeds as may be considered by the Receiver to be incidental or conducive to any of the matters or powers listed here or granted by law or otherwise incidental or conducive to the preservation, improvement or realisation of the Secured Assets and to use the name of the Chargor for all the purposes set out in this clause 13.

13.4 Remuneration

Santander may from time to time fix the remuneration of any Receiver appointed by it.

14 Delegation

Santander and any Receiver may delegate by power of attorney or in any other manner all or any of the powers, authorities and discretions which are for the time being exercisable by Santander and the Receiver (as appropriate) under this Deed to any person or persons as it shall think fit. Any such delegation may be made upon such terms and conditions (including the power to sub-delegate) as Santander and Receiver (as appropriate) may think fit.

15 Application of monies

- 15.1 Sections 24(6) and (8) (Appointment, powers, remuneration and duties of receiver) of the CALPA 1881 shall not apply to a Receiver appointed under this Deed.
- 15.2 All monies received by Santander or any Receiver under this Deed and applied in discharge of the Secured Liabilities shall be applied to the Secured Liabilities in such order as Santander may determine.

15.3 Santander and any Receiver may place any money received, recovered or realised pursuant to this Deed in an interest bearing suspense account and it may retain the same for such period as it considers expedient without having any obligation to apply the same or any part of it in or towards discharge of the Secured Liabilities.

16 Remedies and waivers

- No failure to exercise, nor any delay in exercising, on the part of Santander or any Receiver, any right or remedy under this Deed shall operate as a waiver, nor shall any single or partial exercise of any right or remedy prevent or restrict any further exercise of that or any other right or remedy. The rights and remedies provided in this Deed are cumulative and not exclusive of any rights or remedies provided by law.
- 16.2 A waiver given or consent granted by Santander under this Deed will be effective only if given in writing and then only in the instance and for the purpose for which it is given.

17 Protection of third parties

- 17.1 No person (including a purchaser) dealing with Santander or a Receiver or its or his agents has an obligation to enquire of Santander, the Receiver or others whether the Secured Liabilities have become payable, whether any power purported to be exercised has become exercisable, whether any Secured Liabilities or other monies remain outstanding, how any monies paid to Santander or to the Receiver shall be applied or the status, propriety or validity of the acts of the Receiver or Santander.
- 17.2 The receipt of Santander or any Receiver shall be an absolute and a conclusive discharge to a purchaser and shall relieve him of any obligation to see to the application of any monies paid to or by the direction of Santander or any Receiver.
- 17.3 In clauses 17.1 and 17.2, purchaser includes any person acquiring, for money or monies worth, any lease of, or security over, or any other interest or right whatsoever in relation to, the Secured Assets or any of them.

18 Notices

All notices, demands and any consent must be in writing. Santander may serve a notice or demand on the Chargor at the Chargor's registered address. A notice or demand by Santander will be effective at the time of personal delivery or at 9.00am on the second Business Day after posting. A notice from the Chargor to Santander must be addressed to Santander UK Plc, Operations Middle Office Securities, Ops Block, Ground Floor Area 3A, Bridle Road, Bootle, Merseyside, L30 4GB and will be effective on receipt, if received before 4.00pm on a Business Day, or otherwise on the next Business Day.

19 Assignment

- 19.1 Santander and each Secured Party may assign or otherwise transfer or deal with all or any of its rights under this Deed or any security created by or under it.
- 19.2 The Chargor may not assign or otherwise transfer or deal with all or any of its rights or obligations under this Deed in whole or in part or enter into any transaction which would result in any of those rights or obligations passing to another person or something having similar effect.

20 Certificates and determinations

Any certification or determination by any Secured Party of a rate or amount is, in the absence of manifest error, conclusive evidence of the matters to which it relates.

21 Indemnity

- 21.1 The Chargor shall promptly indemnify Santander and each other Secured Party and every Receiver and delegate, agent, nominee, attorney or co-trustee appointed by Santander (each an Indemnified Person) against any cost, loss or liability together with any associated VAT incurred by any of them as a result of:
 - (a) the taking, holding, protection or enforcement of this Deed;
 - (b) the exercise of any of the rights, powers, discretions and remedies vested in Santander and each Receiver and delegate by the Finance Documents or by law; and
 - (c) any default by the Chargor in the performance of any of the obligations expressed to be assumed by it in the Finance Documents.
- 21.2 The Chargor shall indemnify Santander and each other Secured Party against any and all costs, losses, liabilities or expenses together with any associated VAT incurred by any of them arising (directly or indirectly) out of or in connection with the business or any real property of the Chargor.
- 21.3 Santander may indemnify itself out in respect of, and pay and retain, all sums necessary to give effect to the indemnity in this clause and shall have a lien on this Deed and the proceeds of the enforcement of this Deed for all monies payable to it.

22 Exclusion of liability

The Chargor may not take proceedings against any officer, employee or agent of Santander in respect of any claim it might have against Santander or in respect of any act or omission of any kind by that officer, employee or agent in relation to this Deed and any officer, employee or agent of Santander may rely on this clause.

23 Miscellaneous

- 23.1 A Secured Party may set off any matured, unpaid or any contingent obligation due to it from the Chargor against any obligation (whether or not matured) owed by that Secured Party to the Chargor, regardless of the place of payment, booking branch or currency of either obligation. If the obligations are in different currencies, the Secured Party may convert either obligation at a market rate of exchange in its usual course of business for the purpose of the set-off.
- 23.2 If a term of this Deed is or becomes illegal, invalid or unenforceable in any jurisdiction, neither the legality, validity or enforceability of the remaining provisions nor the legality, validity or enforceability of such term under the law of any other jurisdiction will in any way be affected or impaired.
- 23.3 If Santander believes that any amount paid by the Chargor or any other person in respect of the Secured Liabilities is capable of being avoided or set aside for any reason, then for the purposes of this Deed, such amount shall not be considered to have been paid.
- 23.4 Any settlement, discharge or release between the Chargor and any Secured Party shall be conditional upon no security or payment to or for that Secured Party by the Chargor or any

other person being avoided or set aside or ordered to be refunded or reduced by virtue of any law relating to bankruptcy, insolvency or liquidation or otherwise.

- 23.5 If Santander or any Secured Party receives notice of any other subsequent security or other interest affecting any of the Secured Assets it may open a new account or accounts for the Chargor in its books. If it does not do so then, unless it gives express written notice to the contrary to the Chargor, as from the time of receipt of such notice by Santander, all payments made by the Chargor to Santander or any Secured Party shall be treated as having been credited to a new account of the Chargor and not as having been applied in reduction of the Secured Liabilities.
- 23.6 If Santander enforces the security constituted by or under this Deed at a time when no amounts are due to any Secured Party but at a time when amounts may or will become due, Santander (or the Receiver) may pay the proceeds of any recoveries effected by it into an interest bearing suspense account.
- 23.7 The security created by this Deed is continuing security and shall remain in full force and effect regardless of any intermediate payment or discharge by the Chargor or any other person of any or the Secured Liabilities. It is in addition to any other security held by any Secured Party at any time for any of the Secured Liabilities, may be enforced without first having recourse to any other rights of any Secured Party and is not in any way prejudiced by any guarantee or security now or subsequently held by any Secured Party.
- 23.8 Unless otherwise stated in any Finance Document, a person who is not a party to this Deed has no rights under the Contracts (Rights of Third Parties) Act 1999 to enforce or enjoy the benefit of any term of this Deed or any other document issued or entered into under or in connection with it.
- 23.9 Santander will not be liable for any action taken by it (or any omission to take action) under or in connection with this Deed unless directly caused by its gross negligence or wilful misconduct. Neither Santander nor any Receiver shall be liable in respect of all or any part of the Secured Assets or for any loss or damage which arises out of the exercise or the attempted or purported exercise of, or the failure to exercise any of, their respective powers unless such loss or damage is caused by its gross negligence or wilful acts of default and recklessness. Neither Santander nor any Receiver shall be liable for any losses, liabilities or expenses arising from any act, default, omission or misconduct on the part of any delegate to whom any powers, authorities or discretions are delegated.
- 23.10 For the purposes of the Statute of Frauds (1677), the terms of the Finance Documents and of any side letters relating to the Finance Documents and the Secured Liabilities are incorporated into this Deed.

24 Fees, costs and expenses

24.1 Transaction expenses

The Chargor shall promptly on demand pay Santander the amount of all costs, fees and expenses (including legal fees and stamp duties) together with any associated VAT reasonably incurred by it in connection with the negotiation, preparation, printing, execution, perfection and release of this Deed.

24.2 Enforcement and preservation costs

The Chargor shall, within 3 Business Days of demand, pay to Santander on a full indemnity basis the amount of all costs, fees and expenses (including legal fees and stamp duties) together with any associated VAT incurred by Santander in connection with the enforcement of or the preservation of any rights under this Deed and proceedings instituted by or against Santander as a consequence of taking or holding this Deed or enforcing these rights.

24.3 Interest on late payments

If the Chargor fails to pay any amount payable by it under this Deed on its due date, interest shall accrue on the overdue amount from the due date up to the date of actual payment (both before and after judgment) at the rate and in the manner as set out in the underlying facility agreement. Any interest accruing under this clause 24.3 shall be immediately payable by the Chargor on demand by Santander.

25 Governing law

This Deed and any non-contractual obligations arising out of or in connection with it shall be governed by, and construed in accordance with, the law of Northern Ireland.

26 Enforcement

26.1 Jurisdiction of Northern Irish courts

- (a) The courts of Northern Ireland have exclusive jurisdiction to settle any dispute arising out of or in connection with this Deed (including a dispute relating to the existence, validity or termination of this Deed or any non-contractual obligation arising out of or in connection with this Deed (Dispute).
- (b) The parties to this Deed agree that the courts of Northern Ireland are the most appropriate and convenient courts to settle Disputes and accordingly no party to this Deed will argue to the contrary.
- (c) This clause 26 is for the benefit of Santander. As a result, Santander shall not be prevented from taking proceedings relating to a Dispute in any other courts with jurisdiction. To the extent allowed by law, Santander may take concurrent proceedings in any number of jurisdictions.

26.2 Service of process

The Civil Procedure Rules regarding service and deemed service will not apply to any letter or other communication notifying a claim or serving legal proceedings under or in connection with this Deed, which shall instead be served in accordance with this clause 26.2. Any letter or other communication notifying a claim or serving legal proceedings under or in connection with this Deed may not be made by way of fax and must be made pursuant to clause 18 (Notices).

This Deed has been entered into as a deed on the date given at the beginning of this Deed.
