It is proposed that the following resolutions be passed as special resolution by way of a written resolution pursuant to Chapter 2 of Part 13 of The Companies Act 2006 (the **Resolutions**).

SPECIAL RESOLUTION

THAT the Articles of Association of the Company be amended by inserting the following Articles 26(6), 26(7) and 26(8) after Article 26(5):

"26(6) Notwithstanding anything contained in these articles:

- (1) the directors shall not decline to register any transfer of shares;
- (2) no holder of shares in the Company will be required to comply with any provision of these articles which restricts the transfer of shares or which requires any shares to be first offered to all or any current shareholders of the Company before any transfer may take place; and
- (3) no holder of shares in the Company will have any right under these articles or otherwise to require such shares to be transferred to them whether for consideration or otherwise

where such transfer is:

(a) to:

- i. a bank or financial institution or to a trust, fund or other entity which is regularly engaged in or established for the purpose of making, purchasing or investing in loans, securities or other financial assets or to any affiliate thereof (any such entity a **Financial Institution**) or to any holders of any bonds or notes issued by the company or any of its subsidiaries or holding companies (**Bond Holders**) or an agent or trustee for any Financial Institution and/or any Bond Holders where a security interest has been or is purported to be granted over those shares (each a **Security**) that benefits a Financial Institution and/or any Bond Holders; and/or
- ii. a company or other entity to whom such shares are transferred at the direction of a Financial Institution and/or any Bond Holders or any agent or trustee on their behalf and/or any administrative receiver, administrator, receiver or receiver and manager or similar entity (a Receiver) pursuant to powers granted to it under any Security; and

(b) delivered to the company for registration in order to perfect or protect any Security of a Financial Institution and/or any Bond Holders; or

(c) executed by a Financial Institution and/or any Bond Holders or any agent or trustee on their behalf or Receiver pursuant to a power of sale or other such power under any Security.

26(7) Notwithstanding anything contained in these articles the directors shall not suspend registration of any shares where such shares are subject to the Security of a Financial Institution and/or any Bond Holders.

26(8) No resolution shall be proposed or passed the effect of which would be to delete or amend this article unless not less than 21 days written notice thereof shall have been given to any such Financial Institution by the Company."
