AND UPON the solicitors for the Claimant and for the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT:

- (1) the name of the above named Manches LLP be restored to the Register of Companies
- (2) the LLP do continue in Creditors' Voluntary Liquidation
- (3) the Claimant do serve a copy of this Order on the LLP's former Liquidator within 21 days of the date hereof
- (4) if at the date of registration of this Order with the Registrar of Companies the name of the LLP is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the LLP to OC305898 LLP
- (5) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the LLP is thereupon to be deemed to have continued in existence as if its name had not been struck off

(6) the Claimant do pay to the Registrar of Companies her costs of the said Application in the agreed sum of £300-00

(7) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"

(8) the hearing on 11 May 2021 is vacated.
