

- & Tax LLP ("CAT"), which is insolvent. This sum has been written off for the purposes of the estimated Statement of Affairs, as the prospect of a dividend to the unsecured creditors of CAT cannot be estimated at present
- 3 The LLP's latest statutory financial statement showed debtors of £297,613, although these records have not subsequently been reconciled. The Liquidator will examine the status of these debts in due course, but the majority of the ledger consists of historic bad debts and it is anticipated that limited recoveries, if any, will be made in this regard
- 4 The computer equipment was left in situ when the LLP's former trading premises were sold, as the costs of removal and sale would have exceeded any benefit to the LLP
