PRINCIPAL ACTIVITY & REVIEW OF BUSINESS

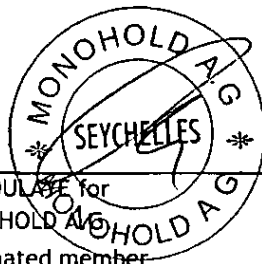
During the current financial period, the company was active as commercial agent for oil products and received commission

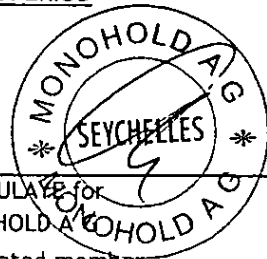


