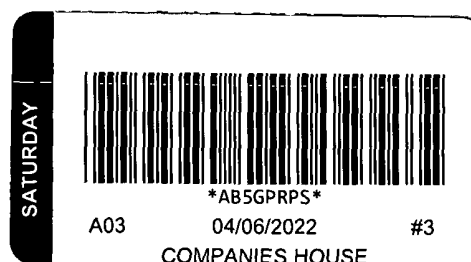

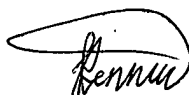

The Members herewith present their report with the Financial Statements of the Partnership for the period ended 28 February 2022.

INCORPORATION & REGISTERED OFFICE

The Partnership registered on 14 February 2005 under Registered Company Number OC311533. The registered office address is at 61 Bridge Street, Kington, Herefordshire, HR5 3DJ, England, United Kingdom.

PRINCIPAL ACTIVITY & REVIEW OF BUSINESS

During the current financial period, the Partnership was active as trade agent for polymeric raw materials and pet, plastic, textile products and food ingredients and received commission.

NOTE

The Partnership primarily conducts business in foreign currencies, such as EURO. These transactions have been converted into Pounds Sterling at averaged exchange rates throughout the current financial year period.
