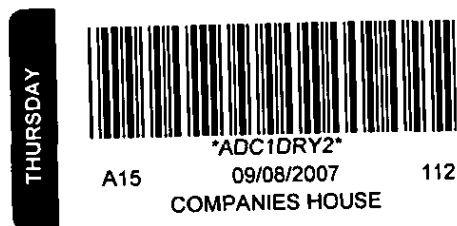



**1 ACCOUNTING POLICIES**
