During the current financial period, the company was active as trade agent for industrial machines and received commission.


**NOTE**

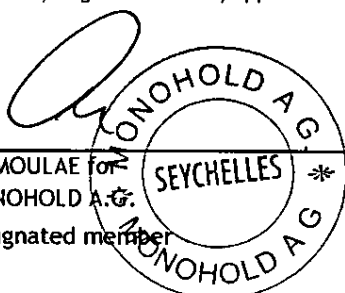
