2. Action taken by the Joint Administrators since their appointment

The company owns a development site at Perth Agricultural Centre, Huntingtower, Perth

The site was previously marketed for sale but disposal could not be completed under terms agreeable to the secured lender

We are now corresponding with the secured lender to assess the options available and the site will be re-marketed at the appropriate time once a strategy has been agreed.

4. Future Actions of the Joint Administrators

As previously advised, the Company's financial position means it is unlikely to have sufficient assets to enable payment of a dividend to unsecured creditors

The secured creditor has approved my fees on the basis of the time properly spent by me and my staff in dealing with matters relating to the Administration of the Company, such time to be charged at the hourly charge out rate of the grade of staff undertaking the work at the time it was undertaken.

To the date this report is prepared, my time costs amount to £52,574, representing 176 8 hours work at an average charge out rate of £297 36, and I have drawn remuneration of £24,723 **Appendix III** contains more information about my remuneration and expenses, including an analysis of the hours worked

1. Explanation of office-holders charging and disbursement recovery policies

1.1. Time recording

Work undertaken on cases is recorded in 6 minute units in an electronic time recording system. Time properly incurred on cases is charged at the hourly rate of the grade of staff undertaking the work that applies at the time the work is done. The current hourly charge out rates are noted on the attached SIP9.

1.2. Disbursement recovery

Disbursements are categorised as either Category 1 or Category 2

Category 1 disbursements will generally comprise external supplies of incidental services specifically identifiable to the case. Where these have initially been paid by FRP Advisory LLP and then recharged to the case, approval from creditors is not required. The amount recharged is the exact amount incurred.

Examples of Category 1 disbursements include postage, case advertising, specific bond insurance, company search fees, case management software system, invoiced travel and properly reimbursed expenses incurred by personnel in connection with the case, (including business mileage up to HMRC approved rate for cases commenced before 1 November 2011). Also included will be services specific to the case where these cannot practically be provided internally such as printing, room hire and document storage

Category 2 expenses are incurred by FRP Advisory LLP and recharged to the estate, they are not attributed to the estate by a third party invoice and/or they may include a profit element. These disbursements are recoverable in full from the Company, subject to the basis of the disbursement charge being approved by creditors in advance. Examples of Category 2 disbursements are photocopying, all business mileage (for cases commencing on or after 1 November 2011), internal room hire and internal storage.
