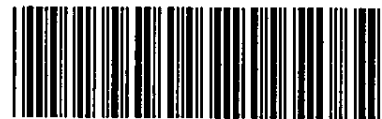
RESPONSIBILITY

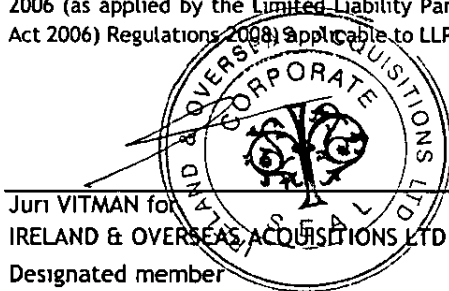
