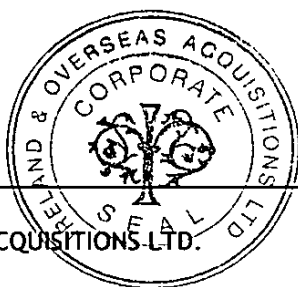
RESPONSIBILITY

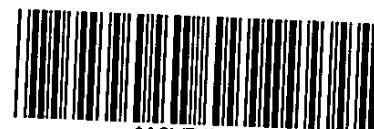

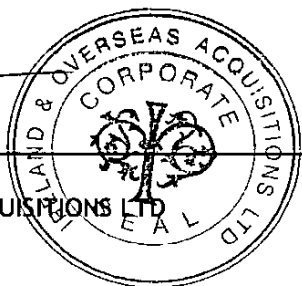
