NOTE

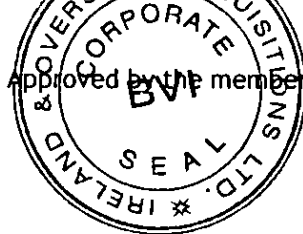
