During the current financial period, the company was active as trade agent for home electronic appliances and received commission

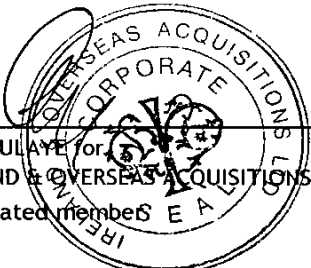
NOTE

RESPONSIBILITY

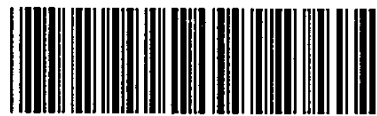
