- (4) <u>Contract Rights</u>: All insurance, insurance policies, rights derived under contract with writers, performers, directors, producers and others, which rights are necessary or desirable to complete and deliver the Picture and exercise the distribution rights with respect to the Picture, including all rights derived pursuant to security agreements and mortgages of copyright with any person or entity with respect to the Picture;
