During the current financial period, the company was active as trade agent for car spare parts and received commission.

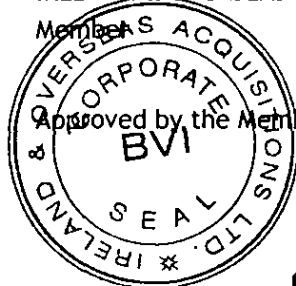
NOTE

RESPONSIBILITY

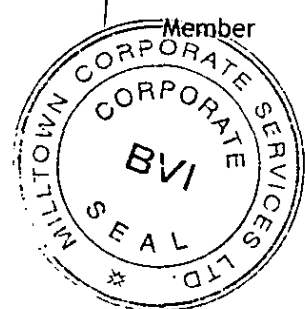
